

SUBJECT: Executive Order No.319. Institutionalizing the moral recovery program (MRP) In all Government Departments, Offices Agencies and Government -Owned and Controlled Corporations through the establishment of integrity circles;

WHEREAS, MEMORANDUM CIRCULAR NO.24. The President Ferdinand R. Marcos, Jr. Was signed establishing the Bagong Pilipinas as administration's brand of governance and leadership. The President emphasis on Moral Recovery Program, Bagong Pilipinas launched and campaign on February 12 2024. The, PBBMovement has made its mission to advance the moral recovery program through the practice and observance of One God, One Nation, One Mission towards Pilipinas Bayang Banal principle promote, honesty and integrity, ensure that the Philippine Constitution is upheld, rule of law is maintained democratic processes are respected and National interests are promoted; to wit ;

WHEREAS, Proclamation no.62 dated September 30 1992 declared a moral recovery program in response to the need to strengthen the moral resources of the Filipino people rooted in filipino culture, values and ideals that are Pro-God, pro-people, pro-Country, pro-nature;

WHEREAS, The same proclamation has declared the moral recovery program as official government policy and enjoined the active participation of all sectors in Filipino society;

WHEREAS, DILG MEMORANDUM CIRCULAR NO.2011-258, dated April 25 2011, provides the significance of Moral Recovery and Values Formation Movement and Program in the provinces, cities, municipalities and barangays nationwide;

WHEREAS, Moral Enhancement Needed for Development Group Incorporated (MENDGI -INC) national office at Brgy. 

COMPOSITION OF THE MRP SECRETARIAT:

WHEREAS, Section 2.3 Operations and support Services staff for the implementation of the programs and projects from the national down to the grassroots level in accordance with MRP goals and objectives; The operational structure of the *national secretariat* shall be replicated at the regional, provincial, municipal/city and barangay levels through the Inter -Agency Councils, in pursuance of it's objectives. Furnished the Head Presidential management staff.

APPROPRIATION FOR THE IMPLEMENTATION OF MORAL RECOVERY PROGRAM.

WHEREAS, Section 4. All the concerned shall allocate 1% of their Human Resources Development (HRD) Training appropriation (GAA-GENERAL APPROPRIATION ACT MOE, MAINTENANCE OPERATIONS EXPENSES) for the initial implementation of their agency MRP, additional appropriation for training may be funded as may determine by the Department of Budget and Management.

WHEREAS, allocation of schedules is, at a convenient place for weekly trainings for 30 minutes or an equivalents of, one and half hours 1- 1/2 for one month.

WHEREAS, The main Objectives in conducting this Moral Recovery Program is to develop the moral standards of Employees in the agency.
