I. Introduction and Rationale

- -Strengthen the rationale with local studies and support with evidence-based data like results of assessments from PISA, TIMMS, NAT or school-based context (like performance Indicators of schools/district) ensure relevance to the variable of interests
- -Include discussion and support from DepEd Policy Guidelines capturing benefits and implications.
- -Indicate the research gaps based on studies presented and the gaps in the locale.

II. Literature Review

- -Present the literature studies topically (based on the variables in the research questions) and embed recent and relevant local studies at least 15 (2015 onwards).
- -Support with local studies, underlying philosophies/theories/frameworks to deepen the study. (Do not just copy from the internet. Do correct paraphrasing and in-text citation).
- -Observe consistent citation and match with the list of references
- -Synthesize the literatures by discussing the similarities and differences of the studies with the present study.

III. Research Questions

- -Arrange research questions from descriptive to inferential or from quantitate to qualitative and the like.
- -Indicate general scope of the objective of the study by stating the school year, school/district/division and respondents.

IV. Scope and Limitations

- -Provide limitations of the study from the coverage of the respondents, tools to be used, locale of the study, methods to be used in the gathering.
- -Indicate possible domains or subsets of the main variable of interest.

V. Research Methodology

a. Research Design

- -Align the research design with the research questions and methods.
- -explicitly define the design (from are reputable source) and qualify the design to be used based on the procedures of your study.

b. Sampling Procedures

- -Discuss the selection processes of the respondents those who will answer the survey and those who will be interviewed.
- -Discuss possible profiles/qualifications of the respondents
- -Define the sampling procedures from a reputable author and qualify your study based on that definition

c. Data Gathering Procedures and research instruments

- -Capture the data gathering procedures/activities necessary to gather the data including the validation of instrument (discuss the qualifications of the validators without naming them).
- -discuss the methods of data gathering including the tools to be used (adopted, researcher-made, modified, or adapted specify)

ANNEX A.2.: GENERAL RECOMMENDATIONS FOR THE <u>ACTION RESEARCH</u> PROPOSALS BASED ON THE SUBMITTED RESEARCH MANUSCRIPTS

I. Context and Rationale

- -Strengthen the rationale with local studies and support with evidence-based data like results of assessments from PISA, TIMMS, NAT or school-based context (like performance Indicators of schools).
- -Integrate at least 15 relevant local studies from 2015 onwards (do not mention the titles in the rationale, discuss immediately their results or implications/recommendations).
- -Discuss current scenario of the school about the variable of interest. Mention the status of the school about the variables and support with data.
- -Include discussion on the experiences of the teachers in relation to the subject matter/variable of interest
- -Discuss the research gaps in the last paragraph including the similarities and differences of the reviewed studies embedded with the current study.

II. Proposed Intervention, Innovation and Strategy

- -Provide theories, frameworks, and approaches to support the proposed intervention
- -Define the proposed intervention based on reputable author and provide the procedures.
- -Explain if there will be modifications from the procedures and strategies incorporated.
- -Discuss the elements of the intervention such as the materials, roles of the teacher and learners, schedule, strategy incorporated and the like.
- -Explain analytically the proposed framework without explicitly mentioning what are found on the boxes.

III. Action Research Ouestions

- -Arrange research questions from descriptive to inferential or from quantitate to qualitative and the like.
- -Indicate general scope of the objective of the study by stating the school year, school /district/division and participants.

IV. Action Research Methods

a. Research Design

- -Define the design to be used based on authors and explain how the study will carry the same procedures based on the definition.
- -Align the research design with the research questions and methods, explicitly define the design and qualify the design to be used.
- -Discuss that the study is an action research and explain why.
- -Specify the use of experimental design such as one-group pre-posttest design, two-group pre-posttest/Quasi-experimental, post-test design only.\
- -Need to define the design and explain how the proposed action research will undergo such process and align to the research questions

b. Participants and other sources of data Information

- -Discuss the selection processes of the participants those who will undergo the pre-posttest, the intervention and interview process.
- -Discuss possible profiles/qualifications of the participants -Discuss the qualifications also of the teachers to validate your instruments or to conduct observations (do not name them).
- -Provide discussions on the other sources of data information (tools or activities to be used, forms, questionnaires and the like)
