## EVALUATION AND FINALIZATION OF PROJECT IMPLEMENTATION PLANS (PIPs) OF SCHOOL HEADS IN READING FOR SCHOOL YEAR 2024-2025

- TO: Assistant Schools Division Superintendent Curriculum Implementation Division Chief School Governance and Operations Division Chief Education Program Supervisors Public Schools District Supervisors/Districts-in-Charge School Heads of Elementary Schools Key Stage 1 Teachers
- The Schools Division Office of Nueva Vizcaya shall conduct an Evaluation and Finalization of Project Initiative Plans (PIPs) of School Heads in Reading for SY 2024-2025 on June 19-21, 2024 at Highlander Hotel and Resort.
- 2. This undertaking is an offshoot of the Division Roll Out on Advancing Basic Education in the Philippines (ABC+) Project on Instructional Leadership Training (ILT) conducted last April 2-6, 2024 to full-fledged elementary school heads, public schools district supervisors and districts in-charge of this SDO.
- 3. This is one of the activities of the division to address the existing gaps in reading arising from the results of Comprehensive Rapid Literacy Assessment (CRLA) and Philippine Informal Reading Inventory (Phil-IRI) Post Tests in Filipino and English of SY 2023-2024.
- 4. The objectives of the activity are:
  - a) To evaluate and provide technical assistance to school head participants in planning activities for reading intervention and enhancement,
  - b) To finalize PIPs of school heads for reading intervention and enhancement, and
  - c) To come up with a unified monitoring tool in the implementation of reading programs in all schools.
- 5. There will be 43 evaluators who will be divided into four groups to assist the school heads in finalizing their PIPs and 161 school head participants to join the said activity. Attached is the List of evaluators and schedule of school heads' presentation of PIPs by district (Enclosure 1) and the list of technical working group (Enclosure 2).
- 6. Meals and snacks of participants, TWG and evaluators, and accommodation of evaluators shall be charged to the of ABC+ Project fund downloaded to the SDO while the travel of participants shall be charged to their local school fund subject to the usual accounting and auditing rules and regulations.
