- 1. In view of the previous memorandum, the school property custodian is requested to receive the units from the Division Office-Supply Office Unit and look for **Ms. Gaye D. Castillo.** The school custodian will receive the five (5) laptops with an Inventory Custodian Slip (ICS), which can be utilized by all teachers (please see attached list). Distribution will commence on July 1 and continue until July 5 of this year.
- 2. Additionally, the school property custodian should maintain a logbook of users and borrowers and property documents as to who is the user at that time in case something happens. Priority will be given to Alternative Learning System (ALS) teachers.
- 3. It is strongly encouraged that the laptops remain within the school premises, as these are "shared" laptops that everyone can utilize.

Note: The teachers may take the laptops outside the school premises if necessary for submitting reports, attending training online or face-to-face, or performing other school-related tasks that require these laptops.

4. The DCP laptops for teachers should remain in their respective schools and shall not be carried or transferred to other schools if the ALS teacher is transferring to a different school, retired, or resigned, as these laptops are budgeted per school.

- 5. The USB recovery drives will be recommended to be retained by the school property custodian, as this is to be used in fixing problems and restoring the functionality of the DCP 2022 laptops for teachers.
- 6. The DCP 2022 laptops for teachers shall only be used for DepEd tasks, and users are strongly advised not to use them for personal transactions or activities.
  - 7. Utmost care and discipline shall be observed in using these government-issued or borrowed devices; the last touch shall be applied in terms of accountability; hence, the school property custodian and ICT Coordinator need to inspect the laptops during the return.
  - 8. The school property custodian or the ICT coordinators shall contact the service provider directly as needed to avail themselves of the 3-year warranty period of the DCP 2022 laptops for teachers and shall submit a narrative report to the Division ICTU quarterly if warranty claims are made.
  - 9. If you discover any of the packages are broken or damaged, please return them as soon as possible to the Supply Office Unit.

  - 11. The transportation expenses to be incurred on receiving the laptop shall be charged to the school MOOE or any available local funds, subject to accounting rules and regulations.
