DIVISION ORIENTATION ON THE IMPLEMENTATION OF THE SCHOOL BASED FEEDING PROGRAM SY 2024-2025 AND SUBMISSION OF BASELINE NUTRITIONAL STATUS

- 1. The Schools Division Office of Nueva Vizcaya through the School Governance and Operations Division- School Health and Nutrition Unit shall conduct a Division Orientation on the Implementation of the School-Based Feeding Program on August 9, 2024, 8:00 a.m-5:00 p.m. at the SDO Conference Hall, Bayombong, Nueva Vizcaya.
- 2. The activity aims to orient participants on the new advisories on the implementation of SBFP SY 2024-2025, discuss Food Safety and Proper Handling of SBFP Commodities and review the Cycle Menu and allocation per school in time for the simultaneous implementation of the feeding program in recipient schools starting August 19, 2024. Relative to this, all incoming enrollees for SY 2024-2025 should undergo assessment of height and weight in time for the submission of Baseline Nutritional Status on August 8, 2024.
- 3. There will be five (5) participants per district to the said activity that includes, the Public Schools Districts Supervisors/DICs, School Heads In-charge of Health and Nutrition, School Nurse Deployment Program (SNDP), Program Development Officer (PDO) and Administrative Officer or ADAS except for Dupax del Norte II with 2 participants only.
- 4. Participants are expected to bring their laptops, chargers and a copy of the District Baseline Nutritional Status 2024 to align the SBFP recipients for SY 2024.
