1. The Schools Division of Nueva Vizcaya through the Curriculum Implementation Division (CID) shall conduct a Training-workshop on Curating Hybrid Learning Space (Making Learning Resources Relevant in Classroom Instruction) on September 12-13, 2024 at the SDO Conference Hall, Bayombong, Nueva Vizcaya.

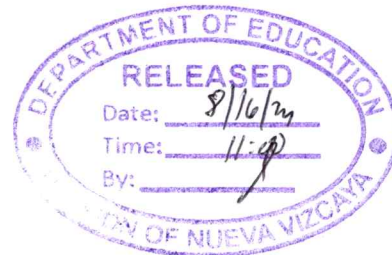
