**POLICIES AND CLAIM GUIDELINES ON PHILIPPINE RED CROSS  
MEMBERSHIP WITH ACCIDENT ASSISTANCE BENEFIT**

1. The insurance **covers accidents** and hospitalization (with contestability) of **MEMBERS ONLY**.
2. Membership shall commence at 1:00 PM on the day of registration and shall expire one year after at exactly 1:00 PM (example: a member who registered on January 1, 2022, his membership will take effect on January 1, 2022 at 1:00 PM and will expire on January 1, 2023 at 1:00 PM). Any accident that commence before the effectivity date or beyond the expiration date and time will not be processed unless membership is renewed on or before the expiration date.
3. Accidents/ confinement/ loss should be reported **immediately thereafter** to the Philippine Red Cross for the claim form, list of requirements and other instructions.
4. **Three (3) days minimum confinement** is required for **Dengue cases** to claim for the Accidental Medical Reimbursement (AMR) and Daily Hospitalization Allowance (DHA).
5. Three (3) days minimum confinement for natural illness to claim for daily hospitalization allowance of **Php 150.00, Php 200.00 or Php 100.00 EXCLUDING FIRST AND LAST DAY**.
6. **Six months contestability for pre- existing conditions (Daily hospitalization allowance will be waived for 6 months from the date of effectivity of coverage).**  
Examples of pre-existing diseases:
  - a. Cardiovascular Disease
  - b. Hypertension
  - c. Diabetes
  - d. Asthma
  - e. Liver Disease
  - f. Appendicitis
  - g. Cancer
  - h. Chronic Obstructive Pulmonary Disease
  - i. Chronic Renal Disease
  - j. Surgery due to Myoma and other chronic diseases
  - k. Pulmonary and Extra Pulmonary Tuberculosis
  - l. Etc.
7. **One month contestability for acute diseases like:**
  - a. Dengue Fever (AMR)
  - b. Typhoid fever (DHA)
  - c. Diarrhea (DHA)
  - d. UTI (DHA)
  - e. Pneumonia (DHA)
  - f. other acute illnesses (DHA)
8. **Animal bite** is covered. Examples: dog bite, snake bite, cat bite.
9. *The policy SHALL NOT extend to cover any loss occasioned by or happening through alcoholism and drug addiction.*
10. Accidents with violations of the Land Transportation Office (LTO) policies like NO HELMET, DRIVING WITHOUT LICENSE, etc is NOT COVERED.
11. **Only PLATINUM MEMBERS who are on OJT or on- the- job training or tourist can claim benefits for accidents that might have transpired outside the Philippines.**
12. Hospitalization due to a disease while on pandemic or epidemic like **COVID- 19 or DENGUE FEVER** is not covered.
13. Injury due to ASSAULT IS NOT COVERED (example: mauling).
14. **NATURAL DEATH OR DEATH DUE TO ILLNESS IS NOT COVERED.**
15. Complete requirements should be submitted to the Philippine Red Cross office **within Twenty- Five (25) days from the date of accident/ confinement/ loss TO PREVENT DENIAL OF CLAIM.**
16. For confinement of **more than 25 days, submit claim form within 25 days** of confinement, other requirements maybe submitted upon discharge from the hospital.
17. Platinum Member submit with 2x2 ID pictures.
