- 4. To ensure that there is no disturbance of classes, the School Head shall guarantee the following:
 - a. All learner participants shall be excused from their respective classes/examination and will be given a special exam on a later date and:
 - b. an alternate Teacher will take over the class of Teacher participant with the Instructional Plans prepared by them.
- 5. Members of the Best Performing Team are required to be present at the venue by 1:00 PM on the scheduled dates of the aforementioned activity to assist with the preparation of training materials.
- 6. The Youth Formation Coordinators and the DFSSLG advisers shall serve as the Chaperones of the learner participants for the whole duration of the activity.
- 7. Participants are requested to bring toiletries, including personal hygiene products, a blanket and a pillow.
- 8. Service credits for teaching personnel and Compensatory Time-Off (CTO) for non-teaching personnel shall be granted in lieu of the activity days that will fall on either holidays or weekends in accordance with DepEd Order No. 53, s. 2003 titled "Updated Guidelines on Grant of Vacation Service Credits for Teachers". respectively.
- 9. Meals and snacks for the duration of the activity will be charged to the Disaster Risk Reduction and Management (DRRM) and Youth Formation Program (YFP) funds. Meanwhile, the participants' travel and other allowable expenses related to the conduct of this activity shall be charged against the School Maintenance and Other Operating Expenses (MOOE) or local funds, subject to the usual accounting and auditing rules and regulations
