Dear **Superintendent Manuel**:

The Civil Service Commission Regional Office No. II (CSCRO II) shall be conducting a ***Tree-Growing For-A-Cause*** in line with the month-long celebration of the 124th Philippine Civil Service Anniversary (PCSA) this September 2024, with the theme: *“Transforming Public Service in the Next Decade: Honing Agile and Future Ready Servant-Heroes.”* This event will take place at designated sites in the provinces of Quirino, Nueva Vizcaya, Isabela and Cagayan.

The activity will be conducted at the Province of Nueva Vizcaya on September 20, 2024 from 7:00 am to 10:00 am at 2012 Graduated NGP Site, Bintawan, Norte, Villaverde, Nueva Vizcaya (*please refer to the attached vicinity map for your reference*).

The Tree Growing For-A-Cause will be one of the activities to be conducted during the 3rd week of the PCSA celebration under the *“Linggo ng Malasakit sa Kalikasan”* theme. This activity emphasizes the critical need to care for our planet and foster environmentalism and patriotism, with two-pronged objectives: to contribute to climate change mitigation through tree-growing and to promote environmental stewardship, while also raising fund for the Pamanang Lingkod Bayani (PLBi) Program which promotes one-time financial assistance to the families of public servants who died in the line of duty.

In this regard, we are delighted to invite your agency to participate in this event by sending representatives to join the tree growing activity. We are also pleased to inform you that we are currently coordinating with the Professional Regulation Commission (PRC) and the Society of Filipino Foresters, Inc. for the possible grant of Continuing Professional Development (CPD) units to members of professions regulated by the PRC.

On this note, the Department of Social Welfare and Development through Solicitation Permit No. DSWD-SB-00034-2024 authorizes the Commission to collect ***a registration fee of two hundred fifty pesos (Php 250.00) per participant*** which shall accrue to the funds of PLBi. Registration fee payments can be made either in person at our CSC Field Offices or via bank deposit to the Civil Service Commission, with Land Bank Account Number 0122-1348-73.


Participants are requested to arrive at the planting site before the designated time and are encouraged to bring their own planting tools and materials, including an eco bag. Additionally, each participant is advised to bring their own water tumbler for drinking, as we discourage the use of bottled water in compliance with RA No. 9003, the “Ecological Solid Waste Management Act of 2000”.
