2. The theme of this year's Division Science & Technology Fair is anchored on the 2024 Science & Technology Week Celebration of the Department of Science & Technology, "*Siyensya, Teknolohiya at Inobasyon: Kabalikat sa Matatag, Maginhawa at Panatag na Kinabukasan*".
3. This activity aims to:
 - a) develop and strengthen the STEM skills of learners through the conduct of research projects that address local, national, and/or global issues, concerns, and problems
 - b) provide an avenue for learners to communicate research findings and showcase their investigations and innovations to the STEM community
 - c) foster a culture of creativity and innovation among the youth
 - d) identify the most creative and innovative learner researchers who shall represent the division in the next level of competition.
4. The participants in this activity are the district winners for the elementary level and the Top 5 qualifiers in the Science Investigatory Projects for the Secondary level.

6. Each district must submit one entry for all the contested activities at the Elementary Level on November 20, 2024, while one entry per Secondary School in the Search for the Most Functional Mobile Science Lab Competition.
7. Manuscripts for the Top 5 finalists of the Science Investigatory Projects and Innovation Expo must be submitted in triplicate to the Records Office, addressed to Ronnie B. Bibas, EPS-Science, on or before October 21, 2024.
8. The Top 5 finalists per category shall prepare their display boards and join the Oral Defense during the Science Congress on November 14-15, 2024.
9. The contest mechanics, rules, and guidelines per category are based on the 2023 National Science & Technology Fair Guidebook which can be accessed via the link https://bit.ly/2023_NSTF_Guidebook.
10. To ensure compliance with the policy on “ *Zero Disruption of Classes* ”, coaches with teaching loads are requested to prepare their Instructional Plans before the approval of their travel authority. However, it is strongly recommended that school heads and/or head teachers shall accompany the contestants during the said competition.
11. A separate memorandum will be issued to provide the list of Technical Working Group Members and Facilitators, along with the event schedule for the 2024 Division Science & Technology Fair.
12. Travelling and incidental expenses of the participants shall be charged against the school and/or local funds while the technical working group's accommodation, supplies, certificates, prizes, honoraria of the panel of judges, and other expenses relative to the conduct of the fair shall be charged to the 2024 PSEF and other local funds subject to the usual auditing and accounting rules and regulations.
