- d. Lack of non-compliance to the requirements will result in automatic disqualification.
- e. All decisions of the Panel of Judges are final and irrevocable.
- f. All entries shall be submitted to the Records Section of the PENARO on or before November 13, 2024, strictly until 5: 00 PM. Failure to submit complete documents on the said date disqualifies a school to be included in the list of entries.
- g. Entries shall be shortlisted through paper assessment and the top five (5) proposals shall be announced on the Youth Formation Unit Facebook Page. Upon the announcement, finalists shall be qualified for the provincial screening wherein both SSLG President and YES-0 Presidents shall defend their proposal and be judged on **November 22, 2024** during the Culminating Activity of the Environmental Awareness Month at the Provincial Capitol, Bayombong, Nueva Vizcaya.
- h. The SSLG President and YES-O President shall be accompanied only by the SSLG or YES-O Teacher-Adviser. Any officers of the SSLG or YES-O may replace their presidents in case their President is not available for the defense.
- All Best Project Proposals shall be included in the Annual Investment Plan 2026 of the Provincial Environment and Natural Resources Office.
