RESOLUTION NO. 2024-5321

**A RESOLUTION DECLARING THE PROVINCE
OF NUEVA VIZCAYA UNDER A STATE OF
CALAMITY DUE TO THE DEVASTATING
IMPACT OF SUPER TYPHOON "PEPITO" IN
ACCORDANCE WITH THE GUIDELINES
PROVIDED UNDER NDRRMC MEMORANDUM
ORDER NO. 60, S. 2019**

WHEREAS, endorsed to this Body and certified urgent by the Honorable Governor Jose V. Gambito is the Nueva Vizcaya Disaster Risk Reduction and Management Council (NVDRRMC) Resolution No. 08, series of 2024 recommending for the declaration of state of calamity in the Province of Nueva Vizcaya due to the devastating impact of super typhoon "Pepito";

WHEREAS, Super Typhoon "Pepito", known internationally as "Man-Yi" has affected thousands of people and left many homes and livelihoods in ruins, particularly in Northern Luzon according to reports. The Province of Nueva Vizcaya is among the areas severely struck and devastated by "Pepito" resulting in extensive damage to lives, properties, livelihoods and communities across its municipalities;

WHEREAS, prior to the onslaught of Super Typhoon "Pepito", the Province of Nueva Vizcaya has been affected by the heavy rainfall, strong winds, and flooding brought about by the series of tropical storms and typhoons such as "Kristine", "Leon", "Marce", "Nika" and "Ofel";

WHEREAS, according to the Situational Report No. 12 submitted by the Provincial Disaster and Risk Reduction Management Office (PDRRMO), as of November 19, 2024, there are 2,534 affected families and 9,318 affected persons, in addition to substantial damages on agriculture and infrastructures to include damages on properties, crops, roads and bridges, health facilities, schools, machineries and equipment;

WHEREAS, in his progress report done in open session today, Mr. King Webster Balawing, Acting PDRRM Officer stated that as of the latest report, the following amount of damages were recorded:

WHEREAS, as per the Situational Report No. 16 submitted by the PDRRMO, as of November 25, 2024, affected constituents totaled to 10,405 families, 36,637 persons and 6,979 damaged houses. An additional cost of damages to infrastructures was stated in the progress report, to include:

WHEREAS, NDRRMC Memorandum Order No. 60, s. 2019 dated June 17, 2019 provides guidelines for the declaration of a state of calamity, particularly Section 3(c), which identifies specific criteria for such declarations, including but not limited to:

- Damage to critical and lifeline infrastructure/facilities, such as major roads, bridges, power stations, potable water supply systems, and telecommunication facilities, which results in:
 - i. Hindered emergency response efforts;
 - ii. Inaccessibility or paralysis of LGU basic services, further aggravating the situation of affected communities;
 - iii. Prolonged service disruption beyond one (1) week;
- Widespread destruction of agricultural resources, including fishponds, crops, poultry, and livestock;
- Disruption of essential lifelines, such as food supply chains, electricity, potable water systems, transport, and communication networks, which cannot be restored within the specified timeframe;



WHEREAS, initial reports indicate that the damaged caused by Super Typhoon "Pepito" meets the thresholds outlined in Memorandum Order No. 60, Series of 2019, as there has been extensive destruction of infrastructure, significant disruption of services, and widespread agricultural losses across the province;

WHEREAS, declaring a state of calamity will empower the provincial Government of Nueva Vizcaya to mobilize resources, expedite emergency response efforts, implement critical recovery measures, and access additional support from national agencies, neighboring LGUs, and other stakeholders to effectively address the impacts of the calamity;

WHEREAS, this declaration will enable the local government units to utilize the Quick Response Fund or stand-by fund for relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by the typhoon may be normalized as quickly as possible;

NOW THEREFORE, on motion of Hon. Patricio F. Dumlao, Jr., unanimously seconded, be it-

RESOLVED, that this Body declares, as it is hereby declaring the Province of Nueva Vizcaya under State of Calamity due to the devastating impact of Super Typhoon "Pepito" in accordance with the Guidelines provided under NDRRMC Memorandum Order No. 60, s. 2019 and based on the Recommendation of the Nueva Vizcaya Disaster Risk Reduction and Management Council through Resolution No.08, series of 2024;

RESOLVED, FURTHER, that this Resolution, together with the PDRRMO reports dated November 25, 2024 and PDRRMC Resolution No. 08, s. 2024, be forwarded to the Honorable Governor Jose V. Gambito, Honorable Mayors and Sangguniang Bayans of the 15 Municipalities of this Province, all Department Heads and Division Chiefs under the Office of the Governor, this LGU, Heads of the Provincial Offices of the different Departments and Bureaus of Government in the Province, Government Service Insurance System, Social Security System, Home Development Mutual Fund (Pag-IBIG), All banking and financial institutions, and all other concerned agencies for their information and guidance.
