- 1. This Office announces the participation of this SDO in the 2024 Batang Pinoy at Puerto Prinsesa, City of Palawan on November 21, 2024 to December 2, 2024 finclusive of travel). The list of selected athletes, coaches, chaperons and delegation officials is herein attached as Memo Enclosure. The selected athletes, coaches, chaperons and delegation officials are PSC registered and validated compliant as per Batang Pinoy requirements.
- 2. All school heads and selected coaches are requested to conduct school-based training ensuring the observance of safety measures in conducting training for sports competition incuding the compliance to the Child Protection Policy.
- 3. All participating athletes are required to submit Parent's Waiver to their coaches while the coaches and delegation officials are requested to attend the Planning Meeting at SDO Conference Hall, Bayombong, Nueva Vizcaya on November 12, 2024 at 1:30 in the afternoon. All coaches are required to submit the athletes' Parents Waiver during the meeting. The planning conference aims to discuss the PSC-Batang Pinoy Guidelines, requirements and travel itinerary.
- 4. The snacks during the planning meeting shall be charged to PLGU Funds while the travel expenses of the participants shall be charged to local funds subject to usual accounting guidelines, rules and regulations.
- 5. All school and SDO personnel who rendered services during the participation in the 2024 Batang Pinov will be granted Service Credits/Compensatory Time-Off in accordance to DO 53 s.2003 for teachers and CSC-DBM Joint Circular No 2, 2002 on Non-Monetary Remuneration for Overtime Service Record for nonteaching upon compliance to the needed requirements.
