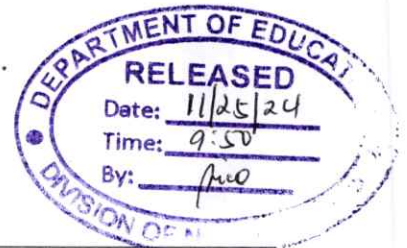

4. The districts’ entry to the NV CIA 5.0 Project are requested to prepare 10 copies of their CI primer and a poster of their project (to be presented in a tarpaulin-3ft-wide; 4ft-height). They are further advised to prepare 10-15 power point slide presentation. The whole package of the project (hard copy) including soft copies of their abstract consisting of not more than 250 words are expected to be submitted on or before December 13, 2024 thru this link <https://tinyurl.com/46shj62m>

5. Expenses to be incurred in this Summit shall be charged against 2024 HRTD Fund and the 2024 FLO-ADM Program Support Fund while the travelling expenses of the participants shall be charged to local funds subject to the usual government accounting and auditing rules and regulations.
