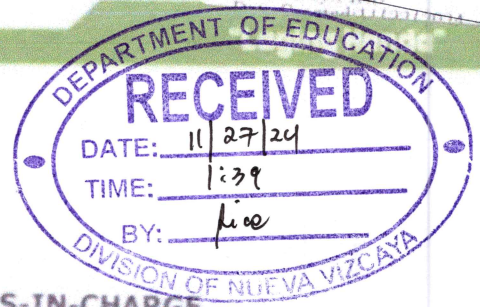

New Venue : **ILAGAN Sanctuary, Santa Victoria, City of Ilagan, Isabela**

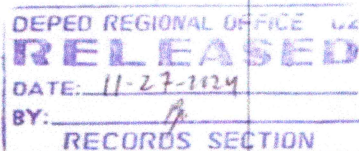
