PROVISION OF FREE MEDICAL SERVICES: CONSULTATION, LABORATORY REQUESTS, AND MEDICAL CERTIFICATES

Assistant Schools Division Superintendent

This is to inform all concerned personnel of the free services provided by the Medical Officer of the Schools Health and Nutrition Unit (SHNU). These services are offered to ensure that the health needs of teaching and nonteaching personnel are adequately addressed. The following services are available:

- 1. Free Medical Consultation: Consultations are available for all teaching and non-teaching personnel who may require medical advice or assessment.
- 2. Provision of Laboratory Requests: Laboratory requests such as Complete Blood Count (CBC), urinalysis, and other necessary tests will be provided, if required, based on the medical evaluation.
- 3. Issuance of Medical Certificates: Medical certificates may be issued following a thorough consultation and review of laboratory results. For those requesting a medical certificate, the following laboratory results must be prepared beforehand:
 - a. Complete Blood Count (CBC)
 - a. Urinalysis

These basic tests are required to ensure an accurate and safe evaluation of the patient's health status before a certificate is issued.

4. Strict Compliance for Medical Certificates: Requests for medical certificates without the proper laboratory results (CBC and urinalysis) will not be processed. The absence of necessary laboratory results may lead to an inaccurate health assessment, which could endanger the medical officer's
