SAMSwela LitMus Contest

General Guidelines

- 1. The competition is open to all high school students in Region 02 who are bonafide students of the participating school.
- 2. The event management team shall only accept 15 registrants on a first-come-first-served basis.
- 3. The online registration form will be open on January 13, 2025. Only complete and correct entries will be sent confirmation email by the SFA Foundation. The registration link will close after reaching the cut off number of participants.
- 4. Each team consists of twenty to twenty-five (20-25) students only (JHS or SHS or combination of both levels).
- 5. Only 1 entry per school is allowed.
- 6. The event allows for only one (1) official teacher-coach.
- 7. Participants (students and coach) are required to submit scanned copies of their IDs (in JPEG or PNG format) and a completed waiver for the event. These documents should be saved as a single file and attached in an email response to the registration confirmation.
- 8. The competition will be held March 22, 2025, 7:30 AM 5:00 PM at the Isabela Capitol Amphitheatre, Alibagu, City of Ilagan, Isabela.
- Schools who have successfully registered online will also need to register on-site to confirm their attendance.
- 10. Transportation and accommodation shall be handled by the participants.
- 11. Attached are the guidelines and mechanics for the contested event.
- 12. Registration is free and no amount shall be collected from the participants.

SamSwela LitMus Contest

Contest Mechanics

The SamSwela LitMus Contest is a celebration of creativity and cultural heritage, where high school students are invited to showcase their talents in both literary composition, musical and theatrical performance. This contest aims to provide the youth a platform to showcase their creativity and exercise their freedom of expression through a combination of skit/drama, solo speech, speech choir, song and dance presentation.

- 1. Successful registrants will receive an email confirmation including the topic or theme for the LitMus.
- 2. The overall LitMus presentation must contain combined elements of speech, speech choir, skit/drama, song and dance and must adhere to the given theme.
- 3. Performance is done live and with audience and must be between 10-15 minutes only.
- 4. Musical instruments, accompaniment, or background during the performance are not allowed. Musical portion of the performance shall be done through a capella or chant.
- Each confirmed participating school are required to submit their LitMus Script on or before March 3, 2025.
- 6. Only participating schools who have submitted their scripts shall be allowed to perform on the event date. Early submission allows for the judges to have ample time to read the content of the script which is part of the judging criteria. Failure to submit the script will result to automatic disqualification.
- 7. All entries must be original, and must reflect the given theme; encoded in A4 bond paper, songs may be original or adapted. Digital copies in PDF format may be submitted to the foundation email address on the set date.
- 8. By entering the contest, participants grant the Samuel Adelan Foundation the right to publish their works on its website, social media platforms, or in any promotional materials related to the contest. Proper credit will be given.
- The SFA Foundation advocates honesty and integrity. Any violation of the contest rules, such as submitting plagiarized work, compromising the performance of other teams or failure to meet submission requirements, will lead to disqualification.
- 10. Best three (3) performers will be recognized. Certificates, trophies and cash prizes await the winners. Consolation prizes will also be given to other participants.

Criteria for Judging

- 1. Creativity (30%): How well the performers showcase the theme through melody, harmony, rhythm, and originality.
- 2. Relevance to Theme (20%): How well the literary musical performance interprets and expresses the theme.
- 3. **Performance Quality** (25%): The quality of the performance (voice and overall presentation).
- 4. Cultural Relevance (15%): The incorporation of traditional elements or cultural stories in the LitMus.
- Script Content (10%): Congruence of the script content to the live performance.
