(English and Filipino, Secondary only


- -1 team (7 student members) per district & their coaches

- 4. Other participants are the CID chief, EPS, Public Schools District Supervisors/DIC, District Campus Journalism Coordinators, District school paper adviser president, Officers of the Association of Nueva Vizcaya Campus Journalism Advocates, and the members of the technical working group.
- 5. The "No Disruption of Classes Policy" shall be strictly observed in the conduct of journalism-related activities.

Learners-participants, coaches and teachers serving as technical workers shall have advanced lessons and make arrangement for modular learning in lieu of their attendance to the DSPC. Teachers shall prepare instructional plans to be supervised by their school heads.

The Division Monitoring Team composed of the EPSs, PSDSs/DICSs shall monitor compliance of all schools on the provision of *DepEd Order No. 09*, s. 2005 titled "Instituting Measures to Increase Engaged-Time-On-Task and Compliance Therewith".

- 6. Expenses in the conduct of the conference such as stipend of judges and speakers as well as their accommodation (board and lodging), meals and snacks of the TWG, certificates, contest materials, transportation, rental of equipment for the contests, procurement of the TV broadcasting equipment and other incidental expenses relative to the conduct of the Division Schools Press Conference shall be charged to Campus Journalism fund from the PSEF subject to the usual accounting and auditing rules and regulations.


