**HEALTH EDUCATION SESSIONS ON DEWORMING AND IMMUNIZATION
DURING PTA MEETINGS**

1. The Schools Division Office of Nueva Vizcaya, through the School Health and Nutrition Unit (SHNU), will be conducting **Health Education Sessions** focused on **Deworming** and **Immunization** during **Parents and Teachers Association (PTA) meetings** across all schools. This initiative is part of our ongoing efforts to promote awareness of essential health programs among parents and guardians, ensuring that learners receive the necessary medical interventions.
2. SHNU Nurses will deliver a 30-minute Health Education session including question and answer segment. This will cover: Importance of Deworming for learners' health; Immunization schedules, benefits, and safety; and addressing common concerns and misconceptions regarding deworming and immunization.
3. **Educational materials** related to deworming and immunization will be distributed to parents during the sessions to reinforce the information presented. Additionally, **waivers for parental consent** for the school-based deworming and immunization programs will be provided during the meeting.
4. The success of these health programs heavily depends on active participation and collaboration between the school, parents, and guardians. It is requested that school heads encourage all parents to attend the PTA meetings and engage in these discussions to ensure their children's health and well-being.
