The introduction should not be more than 150 words or not more than two (2) minutes, Municipal Muse and escort shall be the bearer of the banner or a tarpaulin.
- 9. There should be parade marshals designated by municipal delegation to help line up the parade and communicate with the parade coordinators. They will walk with their groups along the parade route.


