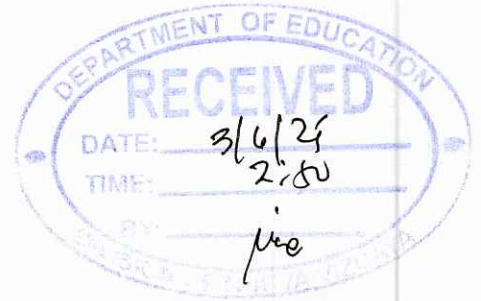

4. **Nueva Vizcaya General Comprehensive High School**


