Greetings!

Harnessing Public Sector Unionism (PSU) is one of the major thrust of the Civil Service Commission. This endeavor provides agencies the opportunity to promote harmonious relationships between the rank and file employees and the management as key partners to effective governance. With the implementation of Executive Order No. 180 in 1987 and with the creation of the Public Sector Labor Management Council (PSLMC), the Commission has been empowered to take further steps toward the creation of atmosphere conducive to good employeesupervisor relations and improvement of employee morale.

Regrettably, there are challenges observed in the implementation of the rules and guidelines on employee unions/association. To help agencies and PSEOs respond to these various challenges, this Office shall conduct (face to face interactions) two-day training intervention called PERSONNEL RELATIONS for ORGANIZATIONAL UNITY and DEVELOPMENT (PROUD) with the general objective of "promoting effective governance thru the empowerment of public sector employees' organizations". The venue will be at the Las Palmas de San Jose Hotel, Tuguegarao City, Cagayan. This will be on April 23-24, 2025 (Wednesday to Thursday) which is equivalent to sixteen (16) CSC technical training hours. Participants are Registered Employees' Union/Association/Organization Officers and Human Management Officers from the national government agencies (NGAs) and government owned controlled corporations (GOCCs).

A fee of FIVE THOUSAND (P5,000.00) pesos will be charged per participant (live out).
