2025 REGIONAL INVENTION CONTEST RULES AND CRITERIA (BY CLUSTER)

1. Rationale

The Regional Invention Contest and Exhibits (RICE) is a nationwide activity conducted by the Technology Application and Promotion Institute of the Department of Science and Technology (DOST-TAPI) in different regions to recognize the indispensability of the Filipino inventors in the Philippine society and in the landscape of national economic development. The Regional Invention Contest (RIC) shall encourage inventors to utilize their innovativeness through competition and with prizes to look out for. RIC serves as the qualifying round for the National Invention Contest, pursuant to Section 4 of the Republic Act (RA) No. 7459 also known as "Inventors and Invention Incentives Act of the Philippines".

2. Clusters

- 2.1 The competition shall be conducted through clusters (ClusteRICE) composed of several regions per cluster. The five (5) Clusters shall be as follows:
 - 3.1.1 National Capital Region (for Cities and Municipalities within the NCR);
 - 3.1.2 Southern Luzon (for Regions IV-A, IV-B and V);
 - 3.1.3 Northern Luzon (for Regions I, II, III and CAR);
 - 3.1.4 Visayas (for Regions VI, VII and VIII); and
 - 3.1.5 Mindanao (for Regions IX, X, XI, XII, and XIII).
- 2.2 Each cluster must have at least three (3) entries to be considered a cluster. Entries in clusters which will fail to meet the required number of entries but if merged together will be able to satisfy the same, shall compete against each other in a Wild Card Cluster. Otherwise, such entry/entries will be joined to any of the geographical adjacent cluster. For purposes of residential requirement, proof of residency already submitted prior merging of clusters need not be changed.

3. Invention Contest Categories

- 3.1. The invention contest for this year is open to both the public and private sector inventors and researchers within the Regions of the Clusters. There are five (5) categories where talented Filipinos can compete in the invention contest, namely:
 - 3.1.1. Outstanding Invention (Tuklas Award);
 - 3.1.2. Outstanding Utility Model (Unlad Award);
 - 3.1.3. Outstanding Industrial Design (Banghay Award);
 - 3.1.4. Outstanding Creative Research (Likha Award); and
 - Outstanding Student Creative Research (Sibol Award) for High School and College students.
- 3.2. Invention Category: Invention refers to any technical solution of a problem in any field of human activity which is new, involves an inventive step and is industrially applicable. It may be, or may relate to a product, or process, and their improvements, (Sec. 21, RA 8293). It shall be covered by letters patent still in force granted by the Intellectual Property Office of the Philippines

K

(IPOPHIL). The category may be subcategorized into *Invention (Privately-Owned Technology)* and *Invention (Government-Owned Technology)* Categories.

- 3.3. Utility Model (UM) Category: Utility Model refers to any technical solution of a problem in any field of human activity which is new and industrially applicable, within contemplation of the above statute (Sec. 109, RA 8293). It shall be covered by utility model registration with a valid registrability report still in force granted by (IPOPHIL).
- 3.4. Industrial Design (ID) Category: Industrial Design refers to any composition of lines or colors or any three—dimensional form whether or not associated with lines or colors: Provided, that such composition or form gives a special appearance to and can serve as pattern for an industrial product or handicraft within the contemplation of the above statute (Sec. 112, RA 8293). It shall be covered by industrial design registration with valid registrability report still in force granted by the (IPOPHIL).
- 3.5. Creative Research Category: Creative Research refers to patent pending inventions, registration pending utility models and industrial designs and research results not yet applied for patent, utility model and industrial design registration. Eligible under this category are new and useful machines or devices or gadgets, products or processes or an improvement of any of the foregoing; and non-biological or microbiological processes not contrary to public order, morals, public health and welfare. These are research results with demonstrable qualities and potential for improvement and/or widespread commercialization or dissemination. The Creative Research Category (Likha Award) shall be subcategorized into (a) Government-Funded and (b) Privately-Funded if there are at least three (3) qualified entries in both subcategories. However, if entries on either of the sub-category is less than three (3), the two (2) subcategories shall be merged into one (1) category only.
- 3.6. Student Creative Research Category (Sibol) Category: Student creative research refers to new and innovative projects or models developed by students in secondary and tertiary levels. These projects or models should possess features and characteristics that may have significant contributions to the promotion of Science and Technology (S&T) innovations that are not contrary to public order, morals, public health, and welfare. The category will be sub-categorized into Student Creative Research for College and Student Creative Research for High School Categories. Out of School Youth (OSY) ages 13 to 18 years old at the time of application shall belong to High School Category. OSY ages 19 to 24 years old at the time of application shall belong to the College Category. OSY ages 25 and above shall belong to the Creative Research Category.

4. Eligibility

- 4.1. Citizenship.
 - 4.1.1. UM, ID, Creative Research, and Student Creative Research Categories. Individual who is a Filipino Citizen at the time of the submission of entry.



4.1.2. Invention Category. Individual who is a Filipino Citizen at the time of the submission of entry or a Philippine government office.

4.2. Residence.

- 4.2.1. Invention, UM, ID, Creative Research, and Student Creative Research Categories (for OSY). At least six (6) months resident of, or whose principal office is located in, the Regional Cluster where the entry is submitted.
- 4.2.2. Student Creative Research Categories (for High School/College Student). Currently enrolled in a campus or branch located in the Regional Cluster where the entry is submitted.

4.3. Technology.

- 4.3.1. Invention, UM, and ID Categories. Owner of a registered and existing UM, or ID or an assignee thereof whose name appears in the IP registration as inventor or researcher, whichever is applicable, provided that in case of government-owned technology, said deed of assignment is required.
- 4.3.2. Invention Category. Owner or a registered and existing Patent or an assignee thereof whose name appears in the IP registration as inventor or researcher, provided that government-owned technologies may be grouped under a separate subcategory from privately-owned technology where no deed of assignment is necessary.
- 4.3.3. Creative Research and Student Creative Research. Author of a scientific research involving a registrable technology as its primary subject.

4.3.4. Previous Winner.

Entries that have previously won 1st, 2nd, or 3rd place in any category or subcategory of past Regional or National Invention Contests and prior to the issuance of these guidelines shall no longer be eligible to participate in subsequent Regional Invention Contests within the same category. However, entries that have won under the Creative Research and Student Creative Research Categories may still join the invention or UM category, provided they have been granted IP registration. Likewise, those entries who will win in connection to Section 6.8 and 6.9 of this current guideline will also be deemed ineligible for future Regional Invention Contests.

4.3.5. Group Contestants. In case of invention, UM, ID, or creative research by a group, all members must sign in the accomplished entry forms, or sign waivers and other relevant documents if they are not joining the contest.

5. Documentary Requirements.

- 5.1. Qualifying Round.
 - 5.1.1. Competent proof of Identification bearing picture, signature, and citizenship.
 - 5.1.2. Birth Certificate and/or Barangay Identification Card (For Out of School Youth participants)
 - Sangguniang Kabataan and/or Barangay Endorsement (For Out of School Youth participants)
 - 5.1.4. Proof of Residence.
 - Private Individual and Out of School Youth. Certificate of Residency.
 - 5.1.4.2. Student ID.

5.1.5. Technology.

- 5.1.5.1. Invention, UM, ID and creative research Categories. One (1) Copy of the completely filled-out entry form RIC Form No. 01A, herein attached as **ANNEX** "A" including:

 - 5.2.5.2. RIC Form No. 6 Certification for Entries under the Student Creative Research Category (Sibol Award), herein attached as ANNEX "6" or ANNEX "7" in case of underage student

6. Procedures

6.1. Submission of Entries. Contestants submit their entries through their respective clusters on or before the deadline of submission. All documentary requirements must be submitted at the time of the application. Only entries with complete documents will be acted upon. Entries may join only one (1) cluster. The contestants may later on be required to provide additional information to the judges in order to fully evaluate their entries during the contest proper.



- 6.2. Prejudicial Disclosure. All contestants shall be responsible in protecting their technology against prejudicial disclosure.
- Formality Check. The Secretariat of the respective Cluster conducts formality and initial eligibility check.
 - Complete. Entries with complete documentary requirements shall be submitted to the respective BOJ for deliberation.
 - 6.3.2. Incomplete. Secretariat calls the attention of the contestant for the submission of the lacking documents and the deadline therefore. Failure to timely submit lacking documents despite extension shall render the entry disqualified.
- 6.4. Qualifying Round. BOJs deliberate on the entries of their respective clusters based on the applicable criteria under the Qualifying Round. At the end of the Qualifying Round, ten (10) entries per category/subcategory will be shortlisted for the final round which may decrease depending on the number available qualified entries.
- 6.5. Final Round. During the final round, scores of all shortlisted entries will be back to zero. BOJ will then deliberate using the Final Round criteria. The contestants may be required to provide additional information in order to fully evaluate their entries.
- 6.6. Exhibit. Only the entries that reach the final round may join the exhibition of the technologies during the ClusteRICE event.
- 6.7. Pitching. ONLY the contestant shall be the one to pitch the entry before the BOJ and answer questions during Q&A portion, if any. In case of group contestants, only one (1) of them shall pitch and answer questions. Pitching of entries that are at risk of prejudicial disclosure shall pitch in a closed-door session limited to attendees with duly executed NDAs.
- 6.8. Minimum Rating for ClusteRICE Winner. No entry shall be declared as 1st place winner in any category or subcategory unless the same garnered an overall rating of 80%. The BOJ may declare no winner or less than three (3) winners per category/subcategory when the 80% requirement is not achieved by some or all of the contestants in that category/subcategory.
- 6.9. Winning Entry. Only ONE entry per category per Cluster will be considered as winner in the ClusteRICE. These winners will qualify to the National Invention Contests and Exhibits (NICE). There will be no 2nd, 3rd, etc. winners.
- 6.10. Decision of BOJ. The decision of the Board of Judges is final and unappealable. The scorecards or rating sheets are considered personal notes of the judges and are not for public scrutiny. Thus, any part of it shall NOT be given to any contestant or any requesting party.
- 7. Board of Judges. The Board of Judges shall be composed of highly qualified professionals thoroughly selected by the DOST-TAPI ClusteRICE Awards Committee. The judges must not be affiliated with any organizations, agencies, schools, or universities of the participating contestants in the regional contest of the same year. The judges must sign a Non-Disclosure Agreement (NDA) with DOST-TAPI prior to judging, herein attached as ANNEX "9".

9. Prizes and Privileges

- 9.1. Cash prizes. All ClusteRICE winners shall receive a cash incentive and certificate of recognition subject to accounting and auditing rules and regulations.
- 9.2. National Qualifier. Winners shall be selected per category or sub-category, if applicable. In case of tie, the Board of Judges shall break the tie via majority vote. The winner in each category or subcategory shall automatically be the national qualifier for the National Invention Contest provided that entries under creative research categories shall submit their technology to the Institute for the availment of TAPI Intellectual Property Rights Assistance Program (IPRAP).
- 9.3. DOST-TAPI will cause the First Prize Winners of the Student Creative Research Category to be featured in available national Science and Technology event(s) for the youth such as the National Science, Technology and Innovation Youth Festival.
- 9.4. The contestants must submit their duly accomplished entries to the respective DOST-RO, DOST-TAPI or directly through the inventions contest link stated in Item 4.1. The DOST-TAPI will pre-screen entries based on compliance to the requirements stated in Item 4.1 of this Rules and Criteria. All documents submitted are subject to final examination by the Board of Judges.
- 9.5. IP Protection of Creative Researches. All contestants in the Creative Research Categories (Likha Award and Sibol Award) shall agree that any intellectual property included in their entries shall be protected under the DOST-TAPI's Intellectual Property Rights Assistance Program (IPRAP). Ownership shall be retained by the contestants or their Assignees, if applicable, who shall also disclose their creative works in full.
- Commercialization. All contestants and winners shall commit to push for the commercialization of their inventions and researches once opportunities are provided.
- Effectivity. This Order shall take effect immediately after posting in the official website of DOST-TAPI.



CLUSTER REGIONS



For 2025, the competition shall be conducted through clusters instead of per region or ClusteRICE. The five (5) Clusters are as follows:

- A. National Capital Region (for Cities and Municipalities within the NCR);
- B. Southern Luzon (for Region IV-A, IV-B and V);
- C. Northern Luzon (for Region I, II, III and CAR);
- D. Visayas (for Region VI, VII and VIII); and
- E. Mindanao (for Region IX, X, XI, XII, XIII)





INVENTION CONTEST CATEGORIES



The invention contest for this year is open to both the public and private sector inventors and researchers within the Regions of the Clusters. There are five (5) categories where talented Filipinos can compete in the invention contest, namely:

- Outstanding Invention (Tuklas Award);
- Outstanding Utility Model (Unlad Award);
- Outstanding Industrial Design (Banghay Award);
- Outstanding Creative Research (Likha Award); and
- Outstanding Student Creative Research (Sibol Award) for High School and College students.







INVENTION CATEGORY

Invention refers to any technical solution of a problem in any field of human activity which is new, involves an inventive step and is industrially applicable. It may be, or may relate to a product, or process, and their improvements, (Sec. 21, RA 8293). It shall be covered by letters patent still in force granted by the Intellectual Property Office of the Philippines (IPOPHIL). The category may be subcategorized into Invention (Privately-Owned Technology) and Invention (Government-Owned Technology) Categories.







UTILITY MODEL (UM) CATEGORY

Utility Model refers to any technical solution of a problem in any field of human activity which is new and industrially applicable, within contemplation of the above statute (Sec. 109, RA 8293). It shall be covered by utility model registration with a valid registrability report still in force granted by (IPOPHIL).







INDUSTRIAL DESIGN (ID) CATEGORY

Industrial Design refers to any composition of lines or colors or any three-dimensional form whether or not associated with lines or colors: Provided, that such composition or form gives a special appearance to and can serve as pattern for an industrial product or handicraft within the contemplation of the above statute (Sec. 112, RA 8293). It shall be covered by industrial design registration with valid registrability report still in force granted by the (IPOPHIL).







CREATIVE RESEARCH CATEGORY

Creative Research refers to patent pending inventions, registration pending utility models and industrial designs and research results not yet applied for patent, utility model and industrial design registration. Eligible under this category are new and useful machines or devices or gadgets, products or processes or an improvement of any of the foregoing; and non-biological or microbiological processes not contrary to public order, morals, public health and welfare. These are research results with demonstrable qualities and potential for improvement and/or widespread commercialization or dissemination. The Creative Research Category (Likha Award) shall be subcategorized into (a) Government-Funded and (b) Privately-Funded if there are at least three (3) qualified entries in both sub-categories. However, if entries on either of the sub-category is less than three (3), the two (2) subcategories shall be merged into one (1) category only.





STUDENT CREATIVE RESEARCH CATEGORY

Student creative research refers to new and innovative projects or models developed by students in secondary and tertiary levels. These projects or models should possess features and characteristics that may have significant contributions to the promotion of Science and Technology (S&T) innovations that are not contrary to public order, morals, public health, and welfare. The category will be sub-categorized into Student Creative Research for College and Student Creative Research for High School Categories. Out of School Youth (OSY) ages 13 to 18 years old at the time of application shall belong to High School Category. OSY ages 19 to 24 years old at the time of application shall belong to the College Category. OSY ages 25 and above shall belong to the Creative Research Category.





MECHANICS

- All submitted entries will be screened by DOST-TAPI in terms of completeness of documentary requirements and will be endorsed to the Board of Judges.
- The contest will have two rounds of judging: the qualifying and final rounds.
- In the qualifying round, the Board of Judges will shortlist the top ten (10) entries per category based on the set criteria indicated in the 2025 RICE Rules and Criteria (by cluster).
- In the final round, scores of all shortlisted entries will be back to zero. BOJ will then deliberate using the Final Round criteria. The top ten (10) contestants will be given a 5 minute presentation to pitch their entry. ONLY the contestant shall be the one to pitch the entry before the BOJ and answer questions during Q&A portion, if any. In case of group contestants, only one (1) of them shall pitch and answer questions
- Only the entries that reach the final round may join the exhibition of the technologies during the ClusteRICE event.
- One (1) NICE Qualifier shall be selected per category and shall automatically qualify in the National Invention Contest and Exhibits (NICE) that will be held the following year (2026).

Citizenship

- UM, ID, Creative Research, and Student Creative Research Categories. Individual who is a Filipino Citizen at the time of the submission of entry.
- Invention Category. Individual who is a Filipino Citizen at the time of the submission of entry or a Philippine government office.

Residence

- Invention, UM, ID, Creative Research, and Student Creative Research Categories (for OSY). At least six (6) months resident of, or whose principal office is located in, the Regional Cluster where the entry is submitted.
- Student Creative Research Categories (for High School/College Student). Currently enrolled in a campus or branch located in the Regional Cluster where the entry is submitted.





ELIGIBILITY

Technology

- Invention, UM, and ID Categories. Owner of a registered and existing UM, or ID or an assignee thereof whose name appears in the IP registration as inventor or researcher, whichever is applicable, provided that in case of government-owned technology, said deed of assignment is required.
- Invention Category. Owner or a registered and existing Patent or an assignee thereof whose name appears in the IP registration as inventor or researcher, provided that government-owned technologies may be grouped under a separate subcategory from privately-owned technology where no deed of assignment is necessary.
- Creative Research and Student Creative Research. Author of a scientific research involving a registrable technology as its primary subject.
