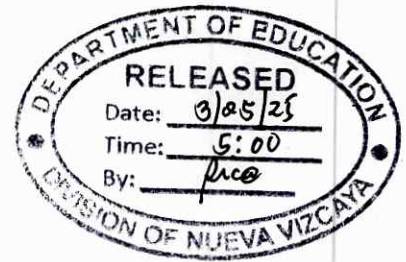

5. Transportation, per diem and incidental expenses of Secondary Nurses shall be charged against the school MOOE subject to the usual accounting and auditing rules and procedures.
