



- 2. The DRRM Team is tasked with ensuring safety, security, and emergency preparedness before and during the event. Their responsibilities include, but are not limited to, the following:
 - Coordinate with the Bureau of Fire Protection (BFP) for the inspection of schools and classrooms designated as billeting quarters and playing venues.
 - Ensure emergency hotline numbers are prominently displayed throughout the school premises and in each designated room.
 - Collaborate with the Health and Wellness Team to facilitate the smooth coordination of emergency cases with the Local DRRM Office or the Municipal Health Office.
 - Partner/Coordinate with the Barangay Local Government Unit (BLGU) to strengthen safety and security measures at all event venues.
 - Perform other tasks as may be required in line with the event.
