We believe that the endorsement from DepEd will lend credibility and visibility to the conference, attracting a wider audience and facilitating greater participation from educational institutions and stakeholders.



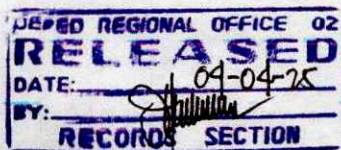

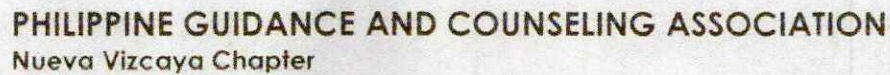
