DUTIES AND RESPONSIBILITIES OF THE BEST PERFORMING TEAM FOR DISCPLINE AND GATEKEEPING FOR THE 2025 CAVRAA

- 1. The members of the BPT for Discipline and Gatekeeping is composed of the district heads with the identified roles and responsibilities during the CAVRAA from April 16-27,2025.
- 2. The members shall monitor the delegation facilities like sleeping quarters, equipment/ paraphernalia's, dining hall, storage room, clinic and others.
- 3. They shall employ friendly disciplinary measures whenever there are violations done by the members of the delegation .
- 4. Give updates, announcements and reminders through phone calls, face to face, bulletin boards, meetings and assemblies as scheduled.
- 5. The members shall resume duty for the delegation with observance of proper time turn over from 6am to 6pm strictly.
- 6. Monitor and request all coaches to be with their athletes wherever they go. BODY BODY SYSTEM is recommended.
- 7. Require all coaches, chaperons, trainers and all others concerned to observe "LEAVING WITHOUT PERMISSION IS PROHIBITED.
- 8. Strictly impose curfew hour at 9pm.
- 9. Monitor the meals of the athletes, coaches, trainers to ensure safety of everyone .
- 10. Monitor and check attendance of the coaches and chaperons and require them to stay with their respective quarters during night time.
- 11. Monitor and check any member of the delegation who enter or leave the quarter to register in the Gate Keeping Team.
- 12. Institute measures for the rewards and recognition for athletes ,coaches and other committees who deserve commendations.
- 13. Implementation of these duties shall be done with utmost sincerity and passion with LOVE for the delegation.
