**SCHOOL-BASED POST ASSESSMENT AND RECOGNITION PROGRAM
FOR PISA SAMPLED SCHOOLS**

1. In line with the issued DepED Memorandum No. 001, s. 2025, “Operational Guidelines on the Implementation of Support to Schools for Improved Learning Outcomes,” this office announces the conduct of School-based Post Assessment and Recognition Program for Sampled Schools in the 2025 Programme for International Student Assessment (PISA) on April 10, 2025 to be held at Solano High School, Kings College of the Philippines Bambang Inc., and Kasibu National Agricultural School.
2. This activity aims to;
 - a. to acknowledge & recognize outstanding achievements and contributions of the forty-two sampled learners, KHAN Academy & Front Learners ESM teachers, staff, and other education stakeholders;
 - b. to encourage continuous improvement and innovation in the teaching-learning, particularly in assessment & other academic activities;
 - c. review instructional methods, curriculum alignment, and school resources that influenced student performance and evaluate the implementation of the PISA 2025 Main survey in the schools;
 - d. design and implement evidence-based strategies to address identified gaps and improve future student performance.
3. School heads are requested to secure Parental Consent/Waiver from the forty-two sampled learners before their attendance in the school-based post-assessment and recognition program.
4. Likewise, all learning facilitators of the KHAN Academy and Front Learners assigned in the three sampled schools, including English, Science, and
