TO RECHARGE, REFLECT, AND RECONNECT

- 1. In line with the agency's commitment to promoting a culture of safety and resilience among its personnel, this office will be conducting **Caring for Carers:** A Wellness Retreat to Recharge, Reflect, and Reconnect on June 5-6, 2025 at Baguio Teachers' Camp, Leonard Wood Road, Baguio City. The retreat will be attended by selected SDO personnel, Registered Guidance Counselors/Senior Guidance Counselors, Katatagan Plus Facilitators, and District Nurses. - 2. This two-day retreat aims to provide a rejuvenating, evidence-based space for participants to reconnect with their personal well-being, learn practical psychological self-care strategies, and strengthen supportive connections within their community. The program integrates key principles from positive psychology, cognitive-behavioral therapy, mindfulness, and trauma-informed care.
- 3. The identified participants are expected to arrive at the venue on **June 4**, **2025** at **2:00PM** for check-in. The first meal to be served will be afternoon snacks of the same day.
- 4. Transportation, per diem, and incidental expenses of the participants for the duration of the activity shall be charged to the respective school's or division's MOOE, subject to existing accounting and auditing rules and regulations.


