

REGIONAL TRAINING ON LITERACY REMEDIATION PROGRAM

- 1. In line with the implementation of the National Literacy Remediation Program stated in DepED Memorandum No. 34 s. 2025, the Department of Education Regional Office No. 2, through the Curriculum and Learning Management Division (CLMD) and the Regional Training Management Team (RTMT), shall conduct the Regional Training of Literacy Remediation Program on May 7-9, 2025 for Cluster I, within Tuguegarao City while Batanes Cluster will be on their preferred date and venue but not later than May 12, 2025.
- 2. Participants to this training shall include the CID Chiefs, one (1) Education Program Supervisor, one (1) school head and teacher-trainers to conduct roll out in their divisions. The allocation list is as follows:

- 3. The training aims to capacitate field implementers in the implementation of the Literacy Remediation Program, forming remediation groups, and delivering explicit, structured teaching sessions. Participants will also be trained on the proper use of Remediation Activity Sheets (RAS) and Learner Activity Sheets (LAS), alongside strategies for providing social-emotional support to learners and fulfilling required documentation and reporting.
- Meanwhile, all expenses relative to this training shall be charged against the 2025
 BEC Learning Camp Fund including TEV of resource speakers and RTWG while travelling

- 5. Teacher participants shall be entitled for 3-day service credits while non-teaching and teaching-related personnel shall be entitled for 3-day compensatory time-off.
- Expected date of Arrival shall be on Day 0- May 6, 2025 at 2:00 pm for registration.
 First meal shall be dinner on Day 0 while last meal shall be lunch and packed snacks on May 6, 2025.
- 7. A Complete Staff Work shall be conducted online on May 6, 2025 at 10:00 am to discuss matters regarding the conduct of the activity. Participants shall be the resource speakers, CID Chiefs, CLMD Staff and other RTWGs.
- 8. Participants shall bring their own laptops, extension cords and other needed tools.


