Application for the Senior High School Voucher Program (SHS VP) of the Takers of the 2024 Accreditation & Equivalency (A&E) Test Junior High School

Reiterating the DepEd Memorandum No. 30, s. 2025, titled **“Application Timeline for the Senior High School Voucher Program and Billing Processing Timelines for GASTPE Programs for the School Year 2025-2026”**, this advisory provides clarification on the application for Senior High School Voucher Program (SHS VP) for those who took the 2024 Accreditation and Equivalency (A&E) Test for Junior High School this year, in coordination with the Government Assistance and Subsidies Services-Operations and Data Management Division (GASS-ODMD), DepEd Central Office.

- Interested SHS VP applicants, who took the A&E Test for Junior High School on January 26, 2025 (Luzon Cluster) and February 2, 2025 (Visayas and Mindanao Clusters) and who have already created their OVAP accounts, may **submit** required documents through Online Voucher Application Portal (OVAP) until **May 16, 2025**, while waiting for the formal announcement of the official test results.
- For ALS A&E Takers under category E, upon receiving the Certificate of Rating (CoR) and confirming their passing the A&E Test, they must submit their CoR together with the ALS Form 5 through the OVAP until **August 29, 2025**.
- The approval of the application for the SHS Voucher Program is subject to the existing policy and guidelines.
- Immediate dissemination of this Advisory is desired.
