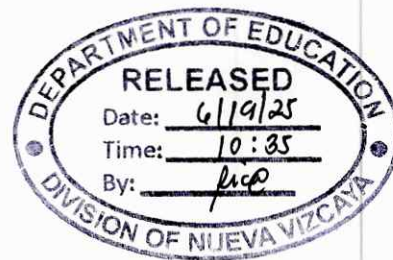

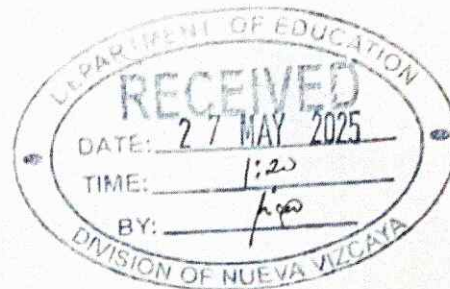

The National Council on Disability Affairs (NCDA), in partnership with the Department of Information and Communications and Technology (DICT) and the Department of Science and Technology (DOST), is pleased to invite your Local IT Challenge (LITC) for Youth with Disabilities achievers to participate in the **2025 National IT Challenge for Youth with Disabilities**, which will be held from **June 24 to 27, 2025**, at a hotel within the National Capital Region (venue to be announced soon).

Full board accommodation (lodging and meals) of up to six (6) participants per local government unit (LGU) will be shouldered by the NCDA. Check-in at the venue will begin at 2:00 PM on June 24, 2025. **Participants should bring their own laptop.**

The event aims to identify and select 12 outstanding students with disabilities who will represent the Philippines in the Global IT Challenge (GITC) for Youth with Disabilities. From these 12 students, the top participant in each disability category (Physical, Intellectual, Deaf, and Visual) will receive full sponsorship for international participation, including plane tickets and hotel accommodation, from the GITC Organizing Committee. Further, students ranked 5th to 12th are still eligible to join the GITC through the support of their respective LGUs.
