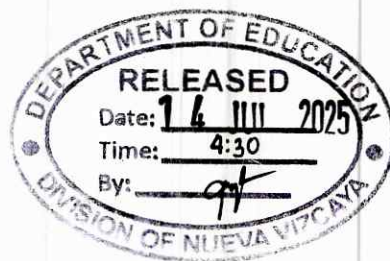

**TRAINING-WORKSHOP ON REMEDIATION AND INTERVENTION STRATEGIES
FOR KEY STAGE 1 TEACHERS OF READING AND LITERACY**

1. The Schools Division Office of Nueva Vizcaya through the Curriculum Implementation Division (CID), shall conduct a 3-day **Training-Workshop on Remediation and Intervention Strategies for Key Stage 1 Teachers of Reading and Literacy** on **July 28-30, 2025**. The venue of the training-workshop shall be announced in another memorandum.

2. After the training-workshop, the participants are expected to:

- a. Reinforce their knowledge in teaching foundational literacy skills to struggling learners;
- b. Nurture the practice of using and employing research-based strategies and techniques in handling learners with learning difficulties;
- c. Provide focused and explicit instruction for their learners;
- d. Support the transition of learners to grade-level proficiency through their enhanced teaching practice; and
- e. Build learners' confidence and foster independent learning strategies.

3. Participants to this training-workshop are the **District English and Filipino Coordinators**, and **Master Teachers** handling Key Stage 1. Please see attached list.

4. The Master Teachers who shall be participating in this training- workshop shall prepare their instructional plans to be carried out by their school heads or the teachers assigned to relieve them of their classroom duties.

5. Meals, accommodation, and training supplies shall be charged to the downloaded centrally-managed fund, while travel expenses of participants shall be charged to their school MOOE subject to the accounting and auditing rules and regulations.
