


- 1. This office informs the field that the conduct of ""PROJECT ARH (Advocating Responsible Health Choices): Reaching the Youth Through their Peer to Promote Well-Informed Decision Making," which was originally scheduled last June 27-29, 2025 is re-scheduled on August 8-10, 2025. The first day of the training, August 8, 2025 will be held at Nueva Vizcaya General Comprehensive High School (NVGCHS) Gymnasium, Bayombong, Nueva Vizcaya. While the remaining 2 days, August 9-10, 2025 will be at DepED SDO Conference Hall, Bayombong, Nueva Vizcaya.
- 2. Attached is the updated list of Secondary schools and selected students who will participate in the training, and a copy of Parent's Consent to be secured for learner's participation.
- 3. Participants who decides to be accommodated at Nueva Vizcaya General Comprehensive High School (NVGCHS) must be accompanied by a Non-Teaching Personnel from their school and shall bring their own beddings. First meal to be served will be morning snack of August 8, 2025.
- 4. The School Health and Nutrition Section shall assign nurses to be on night duty to provide emergency health services during the 3 days training.
- 5. Participants and facilitators on August 9-10, 2025 shall be entitled to service credits/compensatory time off in accordance with **DepED Order No. 53, s. 2003**, "Updated Guidelines on the Grant of Vacation Service Credits to Teachers."
- 6. Meals and snacks shall be charged to the downloaded Program Support Fund FY 2024 of the Adolescent Reproductive Health Program while per diem and incidental expenses of participants shall be charged against the school MOOE subject to the usual accounting and auditing rules.


