**STRENGTHENING LEARNER PROTECTION THROUGH ANTI-BULLYING CAMPAIGNS**

To: Assistant Schools Division Superintendent  
Chief, School Governance and Operations Division  
Chief, Curriculum Implementation Division

Public and Private Elementary and Secondary School Heads

1. In accordance with DepEd Order No. 40, s. 2012 (Child Protection Policy) and DepEd Order No. 55, s. 2013 (IRR of the Anti-Bullying Act of 2013), which mandate the establishment of Child Protection Committees and the implementation of effective anti-bullying programs, this Office through the School Governance and Operations Division, directs all public elementary and secondary schools to **carry out proactive measures against bullying**.

2. To strengthen anti-bullying efforts at the school level, all **School CPCs**, in coordination with **SELG/SSLG** officers and their respective Teacher-Advisers, are directed to undertake the following:

- Intensify anti-bullying campaigns through school-based activities and strategies that promote a culture of respect and child protection.
- Maximize the School/Youth Formation platforms (such as Facebook pages, bulletin boards) by posting creative advocacy materials such as infomercials or any content of your choice (e.g., short videos, posters, digital art, or other learner-led materials promoting anti-bullying awareness).
- Incorporate short anti-bullying messages during Monday flag ceremonies to reinforce learner rights, responsibilities, and safe behavior.
- Partner with stakeholders such as the Parents-Teachers Association (PTA), Barangay Officials, PNP, and local youth-serving organizations to help monitor and secure areas surrounding the school compound, especially during the arrival and dismissal of learners.



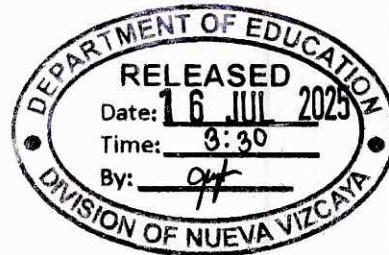
