IMPLEMENTATION OF ADDITIONAL ASSIGNED EXTENSION SCHOOLS TO
SECONDARY SCHOOL NURSE TO MEET THE STANDARD
NURSE-PATIENT RATIO**

1. In reference to Division Memorandum No. 306, s. 2025, this is to inform all concerned of the following clarification regarding nurse assignments:

A. **Nurse Rudy Agustin cannot be assigned** to the following secondary schools at this time:

- a) Alfonso Castañeda NHS
- b) Casecnan National High School
- c) Abuyo National High School

B. **Nurse Ben Clarion Llantada cannot be assigned** to the following secondary schools at this time:

- a) Malabing Valley NHS
- b) Eastern Nueva Vizcaya National High School
- c) Kakiduguen NHS
- d) Kasibu National Agricultural School
- e) Kongkong Valley NHS

2. Both nurses have already reached the **standard nurse-to-patient ratio of 1:5,000** based on their current assignments in elementary schools.

3. Nevertheless, please be assured that **Nurses Rudy Agustin and Ben Clarion Llantada will continue to provide support and coordinate health programs and activities** in these secondary schools and will render nursing services **as necessary and as feasible**.

4. The Schools Division Office is actively working to explore appropriate measures to ensure the **continued provision and strengthening of health and nursing services** in all schools under the Division.



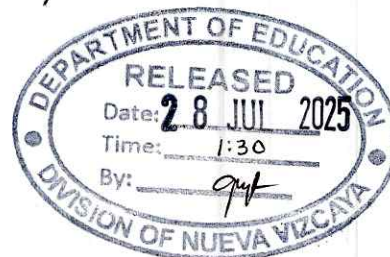
