

- 1. Republic Act 8525 otherwise known as "An Act Establishing the Adopt-A-School Program (ASP) by the Department of Education (DepEd) in the Philippines aims to foster partnerships between private entities and public schools to enhance educational resources and support. Implemented based on the principles of volunteerism and multiple partnerships, the Adopt-A-School Program (ASP) of the Department of Education (DepEd) gives the private sector an opportunity to become dynamic and strong partners towards the noble goal of educating all Filipinos.
- 2. Anent this, this Division Office shall conduct the **AgapED**: **Stakeholders' Initiatives for the ADALantados cum SDO-On-Wheels on August 13-14, 2025 at Cawayan Elementary School, Pelaway, Alfonso, Castañeda, Nueva Vizcaya** as the agency's commitment to reach the far-flung or the Last Mile School which belongs to the Geographically Isolated and Deprived Area (GIDA).
- 3. The objectives of the activity are as follows, to wit:
- a. To deliver essential educational and health services directly to Last Mile School in the District through mobile outreach, i.e. SDO-On-Wheels;
- b. To foster partnerships and strengthen stakeholders engagement in supporting remote learners and teachers;
- c. To provide capacity-building activities for teachers for teachers and school heads in remote areas;
- d. To inspire and motivate learners and teachers by showcasing support and care from various stakeholders;
- e. To gather and share resources, services and best practices among stakeholders to address the unique needs of remote school communities;
