- 1. The Schools Division Office of Nueva Vizcaya, in partnership with the Department of Information and Communications Technology Provincial Office, Bayombong, Nueva Vizcaya, announces the conduct of the Regional TECHQUEST: Robotics & Rubik's Challenge for Academia on September 17-19, 2025, at SM City and NGN Gran Hotel, Tuguegarao City.
- 2. This activity aims to foster innovation, critical thinking, and problem-solving skills among learners, promote logical reasoning and spatial intelligence, and build a STEM-oriented academic culture, nurturing future-ready learners who can excel in technology-driven environments.
- 3. Participants in the said in-person activity are the Top 3 winners during the division level competition. Enclosed are the schedule of activities and the list of the regional qualifiers.
- 4. To ensure compliance with the policy on "Zero Disruption of Classes", coaches with teaching loads are requested to prepare their Instructional Plans before the approval of their travel authority. However, it is strongly encouraged to consider offering advanced classes whenever feasible. If the teacher-coach is unable to accompany the contestants, school heads or department heads are eligible to serve as chaperons during the competition. Likewise, secure Parental Consent from each of the learner-participants.
- 5. Lunch and snacks during the event shall be charged to the DICT Fund, while breakfast, dinner, transportation, accommodation and other incidental expenses of the participants shall be charged against school MOOE or any local funds, subject to the usual accounting and auditing rules and regulations.
