

- 1. - 2. Project OCULUS is a school-based health initiative that aims to strengthen the early detection and management of color vision deficiencies among learners. Specifically, it targets **Grade 7 learners** for color vision screening, promotes awareness on Color Vision Deficiency (CVD), and provides recommendations for appropriate learning support and accommodations to ensure that no learner is left unseen.

immediately after the kick-off program. The screening schedules for the other pilot schools shall be announced in a separate issuance.

- 5. The color vision screening team shall transfer to Namabbalan Integrated School immediately after the screening activity in Libag IS. All screenings for Namabbalan IS learners shall be conducted on-site, within the Namabbalan Integrated School premises.
- 6. All pilot division school health personnel, in coordination with the class advisers, shall secure a Data Privacy Notice and Consent Form prior to the conduct of the screening activity.
- 7. All personnel involved are further reminded to strictly adhere to the provisions of the Data Privacy Act of 2012 in handling and safeguarding learners' information.
- 8. Meanwhile, SDO Tuguegarao City is requested to allot from the recently downloaded Program Support Funds (PSF) for Basic Health Services/Medical, Dental, and Nursing Services (MDNS) and download the same to the host school to cover the meals and other expenses relative to the conduct of the activity, subject to existing government accounting and auditing rules and regulations.
- 9. In addition, travel and other related expenses incurred by health personnel shall be charged against downloaded MDNS PSF/local funds subject to usual accounting and auditing rules and regulations.
- 10. Attached herewith, is the Data Privacy Notice and Consent Form for your reference.
- 11. Immediate dissemination of and strict compliance with this Memorandum are desired.
