

## SUBMISSION OF TERMINAL REPORTS AND REQUIRED DOCUMENTS OF RECIPIENT SCHOOLS OF DONATED LUMBER FROM THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR)

- 1. In connection with the utilization of **donated lumber from the Department of Environment and Natural Resources (DENR)** for the construction of Temporary Learning Space (TLS), repair/ rehabilitation, or improvement of school facilities, all recipient schools under Batch 1 and Batch 2 are hereby directed for the **submission of Terminal Reports** with the required supporting documents.
- 2. This submission is necessary to ensure proper documentation, transparency, and accountability on the use of donated materials, as well as to comply with requirements set forth by the DENR.
- 3. Each recipient school is required to submit the following documents:
  - a. Justification for the construction of TLS or repair/rehabilitation or improvement of school facilities
  - b. Bill of Materials
  - c. Building Plan or Simple Sketch Plan duly signed by the Building Foreman
  - d. Certificate stating that there is no fund or appropriation for the purchase of the required wood materials
- 4. The above documents shall form part of the Terminal Reports to be compiled and submitted in both hard and soft copies to the Education Facilities Unit, Schools Division Office of Nueva Vizcaya on or before October 21, 2025.
- 5. For reference, the list of Batch 1 and Batch 2 Recipient Schools is attached herewith.
- 6. For information, guidance, and strict compliance.




