CUM TA PROVISION ON SBM SELF-ASSESSMENT

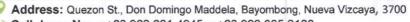
1. As accentuated in **DepEd Order No. 26, s. 2023, the Implementing Guidelines of the Establishment of School Governance Council (SGC),** all public schools must establish their respective SGC, which shall be the overall coordinating body of all committees, associations, and organizations in their schools. This shall translate the principle of shared governance enshrined in RA 9155 and contribute to strengthening the implementation of School-Based Management.

- 2. Likewise, THE sbm Framework, process, and self-assessment checklist constituting the implementation of **DepEd Order No. 007**, **s. 2024** shall guide all public elementary and secondary schools, Schools Division Offices (SDOs), Regional Offices (Ros) and the Central Office in nurturing a culture of continuous improvement of schools' practices and learning outcomes.
- 3. To actualize this mandate, this Office, through the Division Field Technical Assistance shall send the following School Heads in the **Regional Orientation Workshop on SGC Functionality CUM Technical Assistance (TA) Provision on SBM Self-Assessment on November 20, 2025, 8:30AM** at the Main Conference Hall, DepEd Region 02, Carig Sur, Tuguegarao City.
- 4. This activity aims to:
 - a. Orient participants on the policy guidelines for the establishment and functionality of SGC in schools;
