



#### B. General Guidelines

The management of NVPAA Meet Batch 1 shall be guided by the following general guidelines:

- a. The selected athletes and coaches per municipality for Batch 1, Cluster 1 and 2 shall *arrive at the billeting schools* on November 27, 2025 and in the afternoon, respectively. The billeting schools will be determined during the Planning Meeting.
- b. The games will start immediately after the brief *Solidarity Meeting* on November 28, 2025 and December 5, 2025 respectively.
- c. The athletes and coaches shall proceed directly to the playing venues. There will be no centralized Opening Program to be done.
- d. The documents of the participating athletes and coaches shall be submitted until November 24, 2025 for evaluation of the Division Screening and Accreditation Committee (DSAC). The District SAC shall have undergone the evaluation of documents at their district/municipal level.
- e. The presence of Medics is required to all events to be played.
- f. The Monitoring Team and LRP Focal Person will monitor the games management to ensure safety and security of all participating athletes and coaches.
- g. All participating athletes are not required to use new playing unifroms. The previously used or any available playing uniform may do as long as conforming to the design, fitness and other specifications as required.
- h. The selected athletes and coaches for CAVRAA Meet, as a result of the 2 clustered events shall be informed through the issuance of Division Memo.
- i. Athletics secondary girls : Female Pole Vault is now a regular event.
- j. Other activities/information relative to the conduct of the NVPAA Meet Proper (Batch 2) shall be informed through the issuance of a separate Memorandum.


