

FINAL REMINDERS AND GUIDELINES ON SIIF REPORT SUBMISSION

1. All schools in Villaverde and Ambaguio Districts that are recipients of the 2025 School Innovation and Improvement Fund (SIIF) are hereby reminded of the following:

A. Utilization and Liquidation of SIIF Funds

All SIIF funds must be fully utilized and 100% liquidated, and the corresponding reports must be submitted through the SIIF Online School Form on or before December 20, 2025.

B. Submission of School Accomplishment Reports

All School Accomplishment Reports shall be submitted by District and bound and compiled at the District level. Documents must be arranged in the following order:

- 1. Consolidated Physical and Financial Accomplishment Report
- 2. Consolidated Unaccomplished Activities
- 3. Consolidated Concerns, Issues, Gaps, and Proposed Solutions
- 4. Consolidated Effective Practices
- 5. Significant Developments (Baseline Results, Innovations and Improvements Made, Endline Results/Impact)
- 6. Insights

C. Annexes (from All School-Recipients)

The following Annexes shall be submitted by all SIIF school-recipients and compiled at the District level:

- 1. Approved Proposal
- 2. Approved Work and Financial Plan (WFP)
- 3. Significant Developments of each school's SIIF implementation, including:
 - i. Baseline Data (Before SIIF Implementation)
 - ii. Innovations/Improvements and Activities Conducted
