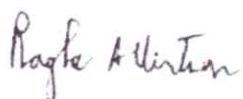

The I AM S.A.M. (Shaker and Mover) Foundation, in partnership with BPW Global Manila, will launch the Please Be Careful with My Heart (PBCWMH) Teacher-Student Challenge on January 24, 2026. This event coincides with the International Day of Education and supports the United Nations Sustainable Development Goal 4: Quality Education.

This initiative reimagines the iconic Filipino song as a scientific, rights-based, and values-driven dialogue between teacher and learner. Through this approach, a duet becomes a living performance of empathy, trust, and responsibility, modeling how care can be expressed safely and respectfully within the school setting.

The program is a nationwide educational advocacy promoting the theme, A Rights-Respecting, Rights-Filled School: My Second Home, under the following pillars:

- Pillar 1: Duet Challenge – Schools submit a teacher-student duet using the official education lyrics, showcasing a rights-respecting relationship.
- Pillar 2: PBCWMH as Practice – Schools commit to embodying the values of the song daily, fostering classrooms that mirror the safety and care of a second home.

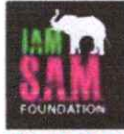

Participation of public and private schools shall be purely voluntary and will not hamper instructional time in compliance with the provisions of DepEd Order (DO) No. 012, s. 2025, titled Multi-Year Implementing Guidelines on the School Calendar and Activities and DO 9, s. 2005, titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith and the policy on off-campus activities stated in DO 66, s. 2017.

### CONCEPT PAPER

#### *Please Be Careful With My Heart (PBCWMH): Two Pillars for Rights-Respecting Schools*

##### **I. Title: Please Be Careful With My Heart (PBCWMH)**

**Pillar I: Teacher-Student Duet Challenge and  
Pillar II: Schools as Second Homes**

##### **II. Background and Rationale**

February offers a special opportunity to renew self-worth, kindness, and the caring relationships that sustain every learning community, where learning flourishes as teachers care gently and students respond with trust and openness to guidance.

This spirit comes alive in the Teacher-Student version of “*Please Be Careful With My Heart*,” which affirms that every learner is loved, precious, and created for a purpose, and that every teacher holds a quiet but powerful responsibility to nurture and protect the hearts entrusted to them. These are the foundations of a rights-respecting, rights-filled school where children feel safe, valued, and supported to thrive.

Anchored on the theme “**A Rights-Respecting, Rights-Filled School: My Second Home**,” PBCWMH celebrates the Filipino ideal of **Schools as Second Homes and Teachers as Second Parents**. Through music and shared performance, the initiative invites schools to cultivate learning spaces where trust, love, and respect are lived each day.

##### **Why It Matters — The Science Behind It**

Neuroscience reveals that learning thrives in a safe and connected environment. When children feel valued and seen by a trusted adult, the brain's prefrontal regions activate for attention and memory; when they feel fear or shame, stress hormones block those same pathways.

The teacher-learner relationship is thus not sentiment; it is science. It is evidence-based nation-building through neuroscience, safety, and love. Making schools second homes is how we grow healthy brains and responsible citizens.

Evidence from global and Philippine studies supports this foundation:

1. **Bullying depresses achievement.** In PISA 2018 and 2022, Filipino students reported some of the world's highest bullying exposure—about 65% in 2018 and roughly one-third in 2022 said they were bullied several times a month. Students who experience bullying score markedly lower and disengage academically.
2. **Violence and trauma impair learning.** The National Baseline Study on Violence Against Children (NBS-VAC) found that nearly 80% of Filipino children endure at least one form of violence, with direct links to anxiety, absenteeism, and poor academic performance.
3. **Online harm is widespread.** Cyber-violence affects around 44% of Filipino children aged 13–17 and is associated with anxiety, lost concentration, and missed school days.
4. **Self-worth predicts performance.** Longitudinal meta-analyses show that students' self-concepts and self-beliefs predict later achievement, confirming that confidence and belonging accelerate mastery.
5. **Teacher relationships matter.** International research demonstrates that warm, structured, and caring teacher–student relationships significantly boost motivation, learning outcomes, and socio-emotional health.
6. **Supportive teachers buffer harm.** In environments with high peer victimization, caring teachers mitigate the negative effects of bullying, sustain engagement, and help learners remain hopeful about their future.

PBCWMH translates this evidence into a simple, culturally resonant program where teachers publicly model care, students feel seen and valued, and schools strengthen the climate that supports both **learning today and futures tomorrow**.

### III. Objectives

The PBCWMH initiative aims to:

1. **Affirm the heart of teaching** by honoring the caring, protective role of teachers in learners' lives.
2. **Strengthen learners' sense of self-worth and safety** through positive, rights-respecting messages.
3. **Encourage schools to live their role as “second homes”** where kindness, respect, and protection are practiced daily.
4. **Provide a simple, unifying national activity** that highlights caring teacher–student relationships and safe, nurturing school environments.
5. **Support efforts to reduce bullying, violence, and emotional harm** in schools through a values- and science-based approach.

### IV. Theory of Change

If schools publicly model **student worth** and **caring adult protection** through a shared creative act that is safe, joyful, and rights-respecting, then:

- learners experience cues of belonging and safety,
- teachers receive recognition and “scripts” for gentle, consistent care, and
- communities see and normalize respectful, trust-based interactions.

Therefore, bullying and related harms are countered by a stronger classroom climate, improving engagement and readiness to learn. When this is followed by school-wide practice (Pillar 2), the message of self-worth and protection moves from a single event into the everyday “culture” of the school.

## V. Program Design: Two Pillars

### Pillar 1 – Teacher–Student Duet Challenge

Pillar 1 focuses on the performance of the Teacher–Student version of “Please Be Careful With My Heart.”

- A **Teacher–Student pair** from each participating public K–12 school performs the official Teacher–Student version of the song.
- The duet presents the song as a **rights-respecting dialogue**: the child as loved, precious, and worthy of care; the teacher as a gentle, trustworthy protector and guide.
- School, division, and regional screenings lead to a **National Showcase on 28 February 2026**, where selected duets are featured and honored.
- The contest ensures basic fairness and inclusion: entries must be recorded and rendered by the school community, not professionally outsourced.
- This pillar highlights the **life-shaping bond** between teacher and learner and reminds the nation that every child's heart is sacred.

### Pillar 2 – Schools as Second Homes Showcase Contest

*(PBCWMH as School-Wide Practice)*

Pillar 2 turns PBCWMH into a school-wide practice, not just a one-time performance.

Over a defined period, schools are invited to **imbibe and embed** PBCWMH in their daily routines, systems, and school culture—treating it as part of the “**DNA**” of the **school** as a Second Home and teachers as Second Parents. This will also be run as a showcase contest, with recognition for schools that demonstrate sustained, concrete practice.

Participating schools will document actions, steps, and initiatives such as:

- daily greetings and language that convey care, respect, and self-worth;
- visible reminders—posters, bulletin boards, classroom visuals—that carry key PBCWMH messages;
- homeroom or guidance activities on anti-bullying, non-violence, and self-worth;
- regular sharing of short videos or testimonies from teachers, students, and parents about how PBCWMH is helping their school feel more like a Second Home and their teachers more like Second Parents.

Schools will later submit a simple documentation package (e.g., selected photos, short video clips or links, and a brief narrative reflection) showing how they have integrated PBCWMH into daily practice and how learners are experiencing change.

Experience has shown that even strong education initiatives can sometimes remain one-time activities unless they are intentionally imbibed and embedded into the very “DNA” of school life. Pillar 2 is our joint and collective response: a practical, school-owned way to weave PBCWMH into daily routines and relationships, and to deepen efforts against bullying, violence in schools, and low self-worth, so that learners can feel safer, learn better, and build stronger futures.VI. National Participation Targets (Pillar 1)

To guide planning and resourcing for Pillar 1:

- **Minimum eligible entries:**
  - Luzon: **≥ 180** entries across NCR, CAR, Regions I–V, IV-A, IV-B
  - Visayas: **≥ 75** entries across Regions VI–VIII
  - Mindanao: **≥ 120** entries across Regions IX–XIII, Caraga, BARMM
  - **Total: ≥ 375** eligible entries nationwide
- **Eligibility rate:** At least **85%** of submitted entries cleared as eligible (complete consent packs, policy compliance, correct materials)

## VII. Governance and Roles

### National Board of Judges (“Big Board Judges”)

- Chaired by **Jose Mari Chan**, with Co-Chair and distinguished leaders from public service, business, diplomacy, and the social sector.
- Adjudicates the **18 regional winners** and names the **3 Island Winners** (Luzon, Visayas, Mindanao), plus an optional **National Laureate**.

### Island Leads (Luzon, Visayas, Mindanao)

- Women leaders serve as Island Leads with small teams, responsible for:
  - forming island/region panels,
  - overseeing screening and deliberations,
  - ensuring compliance with guidelines and safeguarding standards,
  - submitting the 18-entry national slate to the Secretariat.

### Department of Education (DepEd)

- Issues the Secretary's directive and advisory to regional and division offices.
- Designates regional and division focal persons.
- Cascades the program to schools, facilitates participation, and supports regional judging and safeguarding.

### I AM S.A.M. Foundation – National Secretariat

- Prepares official materials (Concept Paper, Call for Entries, forms, micro-modules, media kit).
- Manages platforms for submissions and data collation.
- Oversees safeguarding and data privacy in coordination with DepEd.
- Handles national communications, the National Showcase, and overall coordination.

## VIII. Safeguarding and Data Privacy (High-Level)

The initiative is grounded in:

- **DepEd Child Protection Policy** (DepEd Order No. 40, s. 2012),
- the **Data Privacy Act of 2012 (RA 10173)** and its IRR, and
- **DepEd Order No. 125, s. 2021** on data governance and management.

Key principles:

- Learners' **dignity and safety** are paramount.
- Public-facing materials use **first names/initials only** for learners; surnames are not used in public outputs.
- Standard **Parent/Guardian Consent, School Head Attestation & Authenticity**, and **Teacher Consent** forms are required and kept on file (recommended retention: 36 months).
- Access to submitted videos and forms is restricted to authorized personnel for judging, documentation, and reporting purposes only.

### IV. Guidelines for Participation

#### A. Eligibility and Coverage

- Who may join**
  - Open to all **public K-12 schools, including Alternative Learning System Centers**, nationwide.
- Number of entries**
  - Each school may submit **one (1) official entry** only.
- Composition of entry**
  - Each entry is a **Teacher-Student pair** from the same school.
  - The teacher must be currently assigned to that school; the student must be officially enrolled there.

#### B. Mechanics of Participation

- Song and Version**
  - Use only the official **Teacher-Student version** of "*Please Be Careful With My Heart*" (lyrics and minus-one provided in **Annex A** and through DepEd/I AM S.A.M. channels).

## 2. Performance Video

- **Length:** up to **3 minutes and 30 seconds (3:30)**
- **Orientation:** Landscape (horizontal)
- **Setting:** Any safe, appropriate school space (classroom, library, stage, multipurpose hall, etc.)
- **Attire:** School-appropriate clothing; costumes are optional.
- **Tone & behavior:** The atmosphere must model **kindness, respect, and child-safe interaction**. No scenes of harm, humiliation, or ridicule.

## 3. Performance Focus

- Gentle, sincere delivery of the song.
- Clear interaction between teacher and student (eye contact, supportive gestures).
- Simple staging; no need for expensive production. Content and relationship matter more than props.

## V. Entry Components and Submission Checklist

Each participating public school must upload **all** of the following to the official Google Form:

### 1. Duet Video (Required)

- **Content:** Teacher–Student duet using the official educational lyrics (Annex A – Teacher–Student Version of “Please Be Careful With My Heart”).
- **Maximum length:** 3 minutes and 30 seconds (3:30).
- **Quality:** Clear audio and video (basic phone recording is acceptable).
- **Safety:** No romantic, suggestive, or unsafe content. Interaction must be kind, child-safe, and respectful at all times.
- **Performance focus:**
  - Gentle, sincere delivery of the song.
  - Clear, warm interaction between teacher and student.
  - Simple staging; content and values are more important than production.
- **Production:**
  - The video **must not be professionally produced or sub-contracted** to an external production house or paid service.
  - It should be **recorded and put together by the school community itself** (teachers, staff, learners, and/or parents) using available school or personal equipment.

### File naming format (very important):

## 2. Required Forms (to be uploaded to the same link)

All three (3) forms below must be accomplished, signed, and uploaded with the video:

1. **Annex E – School Head Attestation & Authenticity Form**
  - Confirms that the entry is official, authentic, **recorded/produced by the school (not professionally outsourced)**, and compliant with DepEd policies.
2. **Annex F – Parental/Guardian Consent Form**
  - Grants permission for the learner's participation, recording, and use of the video and related materials.
3. **Annex G – Adult Participant (Teacher) Consent Form**
  - Documents the teacher's consent to participate and to the use of the video and related materials.

**A complete entry consists of:**

- one (1) duet video file (recorded/produced by the school), **and**
- Annex E, Annex F, and Annex G uploaded with the video.

Incomplete or professionally outsourced submissions may be marked **ineligible**.

## VI. Submission Procedures

Before the deadline, each school must ensure that it has:

- Confirmed its official Teacher–Student pair and rehearsed using the official materials;
- Recorded the video according to the guidelines in Sections IV–V;
- Named the file following the required format in Section V; and
- Uploaded the video file and Annexes E, F, and G through the Google Form link provided in Section V.

Late, incomplete, or professionally outsourced submissions may be marked **ineligible**.

## VII. Judging Criteria and Selection Process

### A. Judging Criteria (100 points total)

1. **Message and Values – 40 pts**
  - Conveys care, respect, and student self-worth.
  - Reflects the theme “A Rights-Respecting, Rights-Filled School: My Second Home.”
2. **Performance and Musicality – 30 pts**
  - Clear, expressive singing.
  - Good timing with the music.
3. **Connection and Interaction – 20 pts**
  - Natural, warm interaction between teacher and student.
  - Visible trust and comfort.

#### 4. **Technical Quality – 10 pts**

- Video and audio are clear and watchable (basic phone quality is acceptable).

(Details in **Annex C – Unified Judging Rubric** and **Annex D – How Judges Should Score the PBCWMH Unified Rubric**.)

### **B. Selection Levels**

#### **1. School Level**

- The school selects one official Teacher–Student duet as its entry.

#### **2. Island / Regional Level**

- All entries are received by the I AM S.A.M. Secretariat and endorsed to the Island Leads for Luzon, Visayas, and Mindanao, who oversee the regional judging process and determine the 18 regional winners (one per region).

#### **3. National Level**

- The National Board of Judges ("Big Board Judges") reviews the 18 regional winners and names:
  - 3 Island Winners – Luzon, Visayas, Mindanao; and
  - an optional National Laureate.

#### **4. National Showcase**

- Featured Teacher–Student duets are honored and presented at the National Showcase on 26 February 2026.

### **VIII. Data Privacy & Safeguarding – School Requirements**

To protect learners and comply with **DepEd Order No. 40, s. 2012** (Child Protection Policy), **RA 10173** (Data Privacy Act of 2012), and **DepEd Order No. 125, s. 2021**, schools are reminded that:

#### **1. Names and Identifiers**

- Use **first names or initials only** for students in public-facing materials.
- Do not display surnames, home addresses, or contact information in the video.

#### **2. Consent and Approvals**

- Secure and keep on file:
  - **School Head Attestation & Authenticity** (Annex E);
  - **Parent/Guardian Consent** for the student performer (Annex F);
  - **Adult Participant (Teacher) Consent** (Annex G).

#### **3. Safe Filming Practices**

- Ensure the venue is safe and supervised.
- No depiction of unsafe acts, physical aggression, or degrading behavior.

#### **4. Use of Materials**

- Entries may be used in DepEd and I AM S.A.M. materials (Showcase, compilations, learning modules, and social media) in line with the consent forms and Data Privacy provisions.

## **IX. Overview of Part II – Schools as Second Homes Contest**

*(Pillar 2: PBCWMH as Daily Practice)*

Part II of the PBCWMH program will also be a contest in the sense that school will receive a Role Model Citation. Over and above the recognition, schools, its head and all its stakeholders must focus of the life-changing and uplifting benefits this brings to the school community and country.

While Pillar 1 focuses on the duet performance, **Pillar 2 invites schools to imbibe and embed PBCWMH as a living practice in their daily life** as a Second Home, with teachers as Second Parents.

Over a set period, schools will be encouraged to:

- adopt simple, caring routines (daily greetings, affirmations, and reminders) that reflect the message of PBCWMH;
- place visible reminders around the campus (posters, bulletin boards, corner displays) that highlight kindness, anti-bullying, non-violence, and learner self-worth;
- organize class, homeroom, or guidance activities where teachers and students talk about what it means for the school to be a Second Home and for teachers to be Second Parents; and
- gather short videos or written reflections where teachers, students, and parents describe the impact of PBCWMH on their school climate.

Schools will later be invited to submit a simple documentation package (e.g., selected photos, short video clips or links, and a brief narrative report) as their entry to the Pillar 2 contest. Detailed mechanics, templates, and timelines for additional program components will be issued through DepEd channels and posted on the official “**I AM S.A.M. Foundation**” Facebook page.

**Experience has shown that even strong education initiatives can sometimes remain one-time activities unless they are intentionally imbibed and embedded into the very “DNA” of school life. Pillar 2 is our joint and collective response: a practical, school-owned way to weave PBCWMH into daily routines and relationships, and to deepen efforts against bullying, violence in schools, and low self-worth, so that learners can feel safer, learn better, and build stronger futures.**

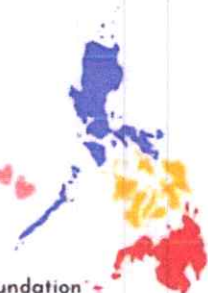

- **Weight** = the maximum percentage contribution to total score (e.g., 30 for Implementation & Creativity).
- **Performance Level** = 5 to 1 scale (Exemplary → Needs Support).

Judges assign **one rating per criterion (1–5 points)** and the system automatically multiplies by its **weight factor** to compute the weighted score.

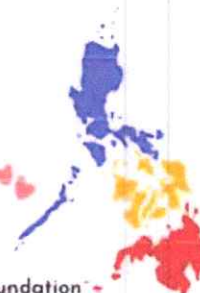

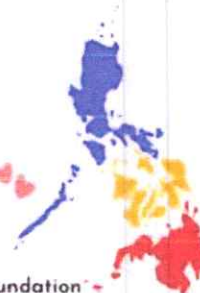
