



This will be held on January 16-18, 2026 at NGN GRAN Hotel, Tuguegarao City, Cagayan with a registration fee of Php 16,500.00. All of the registered participants will also be included in the 3-Day Final Coaching on March 6-8, 2026 via Zoom meeting. These review sessions will help a lot the aspiring School Principals in your region in their preparation for the upcoming the FY 2025 NASH – Batch 2.

The resource speakers of the Team Erich are excellent facilitators in both face-to-face and online review sessions. The following are the members of the review team:

1. Dr. Grant B. Gubatan (2017 Principals' Test Top 1, 2022 CESWE Passer, 2023 EMT/Superintendent Exam and Principal III);
2. Dr. Angelo D. Uy (2018 Principals' Test Top 1, CESE (completed 4 Stages) and PSDS);
3. Dr. Eduardo S. Yabut (2015 Principals' Test Top 5, CESWE Passer and Principal IV);
4. Dr. Romar M. Dayao (NQESH Passer, 2023 CESWE Passer and Principal III);
5. Dr. Easter B. Borallo (NQESH Passer, CESWE Passer and Principal I); and
6. Michael L. Munoz (Review Director of Team Erich)

The review session will prepare its participants in the different five (5) domains under the Philippine Professional Standards for School Heads (PPSSH). All of the 34 strands in the PPSSH are well-distributed in the questions with emphasis on the different four (4) career stages in every strand. Team Erich has been consistently producing National Topnotchers and Regional Top Performers since it was established on January 22, 2017.

The review questions are patterned based on the FY 2025 NASH – Batch 1 which was administered last September 14, 2025. The participants will encounter questions on how to analyze different graphs, tables and data presented. There are also many questions on how to answer data sufficiency test. The questions belong to Higher Order Thinking Skills (HOTS) based on the Structure of the Observed Learning Outcome (SOLO) Taxonomy. A reader can

expect questions classified under Multistructural, Relational and Extended Abstract in the SOLO Taxonomy.

Up-to-date examination materials will be given by the speakers consisting of the latest 2025 and previous DepEd Orders and other issuances covered in the examination. Both the new and old normal questions will be presented in the review which are part of the coverage of the PPSSH.

We aim that we may be able to work hand in hand in securing the future of our next leaders through our affiliation as well as to emphasize values formation to our future leaders and educators.
