DUETECTIVES

The Harmonic Showdown

DUETECTIVES: The Harmonic Showdown is a **vocal duet competition** that challenges participants to showcase their musical synergy, vocal harmony, and stage presence. Open to all agent pairs, the event highlights the power of collaboration and performance.

ELIGIBILITY

The competition is open to **all Region 2 participating schools** of the Regional Youth Science, Technology, and Environment Camp (RYSTEC) 2026 organized by the PSYSC Regional Council 2. Each participating school is allowed to send only **ONE (1) DUET ENTRY** composed of **TWO (2) high school students**, both of whom must be registered participants of RYSTEC 2026. These two students may be a combination of Junior High School and Senior High School students, as long as they are from the same school.

NOTE: Participants who are involved in the Dance Competition, any Session Contests (Editorial Writing Contest, Pagsulat ng Editorial, Editorial Cartooning, Poster Making Contest, Capture It!, School Quiz Competition), or the Take-Home Workshops Competition are not eligible to join this contest. If a school withdraws its participants from any NYSTESC activity to prioritize contest practice, the duet will be automatically **DISQUALIFIED** from the competition.

REGISTRATION

There is no registration fee. Registration for the e-night competitions will be included in the official RYSTEC 2026 registration forms. There will be a specific section for the e-night events where schools can input the names of their participants and coaches. Schools may input up to **two (2) coaches** for the singing competition.

If a school has already submitted their camp registration form and later decides to join the e-night competitions, they may still edit their responses in the registration form—since the response form is editable—provided that changes are made before the deadline for e-night competition registration, which is on **February 14 at 11:59 PM**.

This year's theme for the duet singing competition is **"Mystery in Melody: The Power of Duet."** Participants are free to choose any song in any language that showcases harmony, vocal blending, and musicality between the two singers. Original compositions are allowed, provided that a **minus one (MP3 format) is available**. While participants may choose any song, we encourage selections that reflect the spirit of the theme—songs that explore elements of **mystery, discovery, longing, or the search for something greater**.

Songs must be **appropriate for a youth audience**. Entries must not contain vulgar, obscene, profane, discriminatory, or offensive language, gestures, or themes. Songs that promote violence, hate, explicit content, or any form of indecency will be automatically **DISQUALIFIED**.

PERFORMANCE TIME

Each duet is allowed a **maximum of 3 minutes, with an additional 30 seconds each for entrance and exit**. Timing begins once the performance starts. A deduction of 1% from the final score will be made for every **20 seconds** exceeded.

INSTRUMENTAL TRACK

To give participants ample time to prepare their music performance background, submission of these materials will be done during the onsite registration for the e-night competitions. Each duet must submit a **USB flash drive** containing the following files:

1. Instrumental track (MP3 format). This is the **minus one track** for the performance. Live instruments are not allowed. The track must not exceed **3 minutes**.

A file must be placed in a single folder labeled with the duet's school name and the event name (e.g., **Calyx High School - DUETECTIVES**). **The flash drive should be submitted during onsite registration on Day 1 of the camp.** The flash drive itself must be physically labeled with the school name to easily identify which school it came from and to ensure smooth and accurate return after the competition.

NOTE: Once the flash drive has been submitted during onsite registration, no replacements or changes will be allowed. The only exception is if there is a confirmed technical issue with the submitted files (e.g., corrupted file, incompatible format, audio/video not playing). EVIDANCE: The Choreographic Clash is a group dance competition that challenges teams to demonstrate their synchronized movements, creativity, and stage presence. Open to all dynamic agent dance crews, this event emphasizes the power of collaboration, teamwork, and artistry in motion.

ELIGIBILITY

The competition is open to **all Region 2 participating schools** of the Regional Youth Science, Technology, and Environment Summer Camp (RYSTEC) 2026, organized by the PSYSC Regional Council 2. Each participating school may send **ONE (1) DANCE GROUP** composed of **TEN (10) to FIFTEEN (15) high school students (including the propsmen)**, all of whom must be officially registered participants of RYSTEC 2026. These students may be a combination of Junior High School and Senior High School students, as long as they are from the same school.

NOTE: Participants who are involved in the Singing Competition, any Session Contests (Editorial Writing Contest, Pagsulat ng Editorial, Editorial Cartooning, Poster Making Contest, Capture It!, School Quiz Competition) or the Take-Home Workshops Competition are not eligible to join this contest. If a school withdraws its participants from any RYSTEC activity to prioritize contest practice, the group will be automatically **DISQUALIFIED** from the competition.

REGISTRATION

There is no registration fee. Registration for the e-night competitions will be included in the official RYSTEC 2026 camp registration forms. There will be a specific section for the e-night events where schools can input the names of their participants and coach. Schools may input up to **two (2) coaches** for the dance competition.

If a school has already submitted their camp registration form and later decides to join the e-night competitions, they may still edit their responses in the registration form—since the response form is editable—provided that changes are made before the deadline for e-night competition registration, which is on **February 14 at 11:59 PM**.

After editing the form, schools are required to send an email confirming the updated entry. The edited registration form should be submitted via email to **rc.2@psysc.org** as proof of the updated response.

THEME & SONG CHOICE

This year's theme for the dance competition is **"Clues in Motion: Searching Discovery Through Dance."** A theme that invites participants to use choreography to simulate uncovering evidence, connecting clues, and arriving at truth, all through the language of dance.

Participants are free to choose any music or song in any language that best supports their choreography and storytelling. Original compositions are allowed, provided that a **high-quality audio track (MP3 format) is submitted**.

PERFORMANCE TIME

Each group is allowed a **maximum of 3 minutes for their dance performance, with an additional 30 seconds each allotted for entrance and exit**. Timing begins once the music or performance starts. A deduction of 1% from the final score will be applied for every **20 seconds** exceeded.

MUSIC TRACK

- Participants must arrive at the venue **at least 15 minutes** before the contest proper.
- Latecomers shall only be accommodated if **NONE** of the participants inside the venue have gone out yet.
- Time extensions will **NOT** be given.

2. **School Details.** A numerical identifier will be given per participant as their submission code. The assigned facilitator will be ensuring that the number identifier is correct.

3. **Duration.** The contest shall be good for **TWO (2) HOURS ONLY**. All papers must be submitted after 2 hours.

4. **Materials.** The oslo paper shall be provided by the organizers. **ALL poster making materials must be brought by the individual contestant.** Only the following materials shall be allowed to be used: oil pastel, crayon, colored pencil, colored pens, ink pens, permanent marker, cotton, pencil, and eraser. **Electronic devices are not allowed** and must be surrendered to their teachers/coaches.

- Participants are not allowed to use electronic devices and reference sketches during the competition.
- The participants are only allowed to draw on the given oslo paper.

CONTEST OBJECTIVES

- To integrate science, technology and environment through visual art
- To foster a venue for imagination and creativity
- To recognize excellence and skill in the arts

MECHANICS

1. **Contest Proper.** The theme for the contest shall revolve on a science, technology, and environmental issue related to this year's RYSTEC topic: **FORENSIC SCIENCE**. Contestants are to give their take on the topic based on their analysis and opinions.

- The topic shall be given at the start of the contest proper.
- Participants must arrive at the venue **at least 15 minutes** before the contest proper.
- Latecomers shall only be accommodated if **NONE** of the participants inside the venue have gone out yet (roamed around to take pictures).
- The contestants are free to roam around within the given time (1 hour).

2. **School Details.** A numerical identifier will be given per participant as their submission code. The assigned facilitator will be ensuring that the number identifier is correct.

3. **Submission.** All images submitted must be taken within the contest proper.

- The entry to be submitted should be a digital file in **JPG format** and must be **at least 1,600 pixels** wide. All entries should be in landscape format.
- The participant will also submit a corresponding **photo title and photo caption** written in a piece of legal pad paper
- The caption must indicate the place where the image was taken, and must have a **brief description** of what the photo is about. The caption must be at least 20 to 50 words.
- All images must **not** be subjected to any post-processes.
- Participants who submitted edited photos will be disqualified.
- Participants must render the SD card used for submission of entries. The SD card **must not contain any file at the start of the contest**. Only **one (1) file** must be chosen and the SD card must be wrapped in a paper with their name written on it, along with the file name of the entry.
 - The SD cards shall be claimed by the contestant after the submission has been transferred by the facilitator to their laptop.
- Only the staff of PSYSC shall layout the submitted entries along with its title and caption that will be printed and posted for exhibit.

4. **Duration.** The contestants are free to roam around the venue for **ONE (1) HOUR ONLY**. The second hour is dedicated for the selection of photos, writing of captions, and the submission of SD Cards.

5. **Materials.** Participants are free to use any model of **Digital Single Lens Reflex (DSLR) cameras**. Participants shall be provided with 2 sheets of legal paper. The participants are only allowed to write their caption on the given pad paper. The other paper is used to wrap the SD card.

CONTEST OBJECTIVES

- To test the participants' knowledge and understanding of science and technology concepts
- To encourage mastery of science concepts through healthy competition
- To recognize excellence of students in the field of science and technology

MECHANICS - ELIMINATION ROUND

1. **Eligibility.** The student contests are open to **both Junior High School (Bracket II) and Senior High School (Bracket III)** participants of RYSTEC 2026. Only **three eligible registrants** per bracket per school shall be allowed to join.

2. **Contest Proper.** The Elimination Round is a written exam composed of **50 Multiple-Choice Questions** and **5 Clincher Questions** overall. The questions will be based on the following categories: **Biology, Chemistry, Physics, Earth Science**, and RYSTEC 2026 Theme: **FORENSIC SCIENCE**.

- a. There will be **10 questions per category**. The clincher questions consist of one question per category, with a random subtopic.
- b. Participants must arrive at the venue **at least 15 minutes** before the contest proper.
- c. Latecomers shall only be accommodated if **NONE** of the participants inside the venue have gone out yet.
- d. Participants should not be allowed to go out of the exam hall during the written exam proper.
- e. A restroom time allowance will be given before starting the written exam.
- f. If such a break is needed during the exam proper, the participant must be required to submit their answer sheets.
- g. Time extensions will **NOT** be given.

3. **Duration.** The contest shall be good for **ONE HOUR AND THIRTY MINUTES ONLY**. All answer sheets must be submitted after 1.5 hours.

4. **Materials.** The questionnaire, answer sheet, and a spare paper for scratch will be provided to the participants. **Participants must also bring their own pencil, eraser, and sharpener.**

- Participants are **NOT** allowed to use a **scientific calculator**. The questions in the elimination round are constructed to be answerable without the use of calculators.

5. **Scoring.** Only the correct answers will be given points and there will be no corresponding deductions for incorrect answers.

- The scores of any participant in the Elimination Round will not be disclosed.

6. **Clincher.** The clincher section points will not be accounted for in the tallying of scores in the written exam. In case of a tie for the top scorers, whoever scores higher in the clincher section will get the higher rank. If the clincher section is tied, whoever submitted the answer sheet first will garner the higher rank.

7. **Qualification for the Final Round.** The scores of individual participants in the team will be **averaged and recorded**.

- The number of teams that will qualify for the final round will follow the mechanics below:

- The finalists will be announced in random order and their scores will revert to zero for the Final Round.

8. The **TOP 3 INDIVIDUAL SCORERS** of the Elimination Round of each bracket shall be recognized and shall receive gold, silver, and bronze medallions and a certificate of recognition.

MECHANICS · FINAL ROUND

1. **Eligibility.** Only participating teams that are qualified for the Final Round shall participate.

2. **Contest Proper.** The Final Round is an **group competition** divided into three (3) levels: **Easy, Average, and Difficult**. The questions will be based on the following categories: **Biology, Chemistry, Physics, Earth Science**, and RYSTEC 2026 Theme: **FORENSIC SCIENCE**.

- Latecomers during the Final Round will **NOT** be allowed to join.
- Each level is composed of **ten (10) questions**.
- The moderator will be reading each question (and choices, if applicable) twice.
 - Contestants are already allowed to write their answer or compute for problem solving questions after the moderator is done reading the question for the first time.
- The scores of the teams per round (not cumulative) will be announced after each round.

3. **Time Limits.**

- For each non problem solving question they shall be answered within a time limit of **10 seconds for the Easy and Average Rounds**, while **20 seconds for the Difficult Round**.
- For problem solving questions, they shall be answered within **1 minute, regardless of the difficulty**.
- The timer will start after the moderator gives the **"GO"** signal.

4. **Scoring.** Three (3) points are given for every correct answer in the Easy level, five (5) points for the Average level, and seven (7) points for the Difficult level.

5. **Contentions.** Only the finalists are allowed to raise contentions. A finalist is not allowed to contest answers of other finalists.

- Contentions shall only be entertained until before the next question is read.

6. **Clincher.** In case of a tie, the concerned participants will proceed to the sudden-death clincher round where the first team to get the correct answer will be declared as the winner.

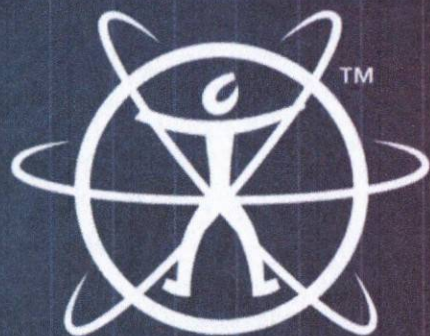

7. **Materials.** The whiteboards, markers, and erasers will be provided to the teams. A spare paper for scratch will also be provided. Teams shall provide their own pens or pencils.

8. The **TOP THREE (3) SCORERS PER BRACKET AND THEIR RESPECTIVE COACHES** shall be recognized and shall receive certificates of recognition. Moreover, the Champion, 1st Runner-Up, and 2nd Runner-Up shall each receive a gold, silver, and bronze medallion, respectively.

9. **Disqualification.** Non-compliance with these guidelines will result in disqualification.

10. The decision of the Board of Judges shall be **FINAL and IRREVOCABLE**.
