**CALL FOR NOMINATION TO THE SEAMEO RECSAM REGULAR COURSES  
FOR FISCAL YEAR 2025-2026 (BATCH 2)**

1. Aligned with DM-OULS-2025-208, this Office invites nominations for the **SEAMEO RECSAM Regular Courses for FY 2025-2026 (Batch 2)**, scheduled from **April 13 to May 08, 2026**. The training will be conducted face-to-face in Penang, Malaysia.
2. The program aims to enhance the pedagogical skills of Science and Mathematics educators. The specific course details and target participants are as follows:

RC-SM-150-4	Integration of Computational Thinking Skills and Coding into Primary/Secondary Mathematics Classroom	Mathematics Educators or Key Primary/Secondary Math Teachers  (Must not be more than 50 years old; Able to communicate in English)

3. The SEAMEO VOCTECH/RECSAM scholarship covers **full tuition fees, economy round-trip airfare, accommodation, and training materials**.

4. Schools Division Offices (SDOs) are encouraged to nominate qualified applicants, based on the following eligibility criteria as per NEAP guidelines:

- a. Must be a Filipino citizen with at least a Very Satisfactory (VS) performance rating for the last two (2) consecutive years.
- b. Must hold a permanent item and have no pending administrative or criminal cases.

- c. Must not have any pending nomination or current scholarship grant.
5. To facilitate the Regional screening and endorsement process, interested applicants must submit their documents to the **Regional Human Resource Development Division (HRDD) / NEAP-R** on or before **February 5, 2026**. This allows time for consolidation prior to the National deadline of February 6, 2026.
6. Required documents for submission (scanned in PDF) include:
- Enclosure 1: Eligibility and Documentary Checklist (PDS, IPCRF, IDP, etc.).
  - Enclosure 2: Scholarship Clearance.
  - Updated Personal Data Sheet and Endorsements.
7. Applications with incomplete requirements or lack of official endorsement may be disqualified.
