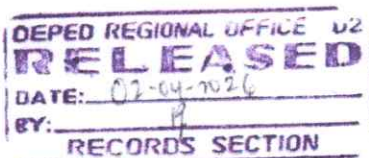

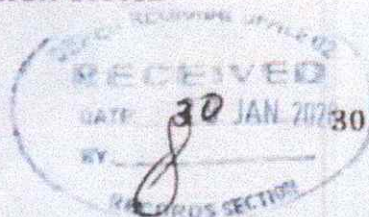
1. This Memorandum is issued to inform all concerned that **Fidelity Capital Investment Group (FGIP)** is not authorized to solicit investments from the public. This is pursuant to a letter from the Securities and Exchange Commission (SEC) addressed to the Office of the Regional Director, categorically stating that the said entity is not registered and has no authority to solicit investments from the public. A copy of the SEC letter is attached hereto for reference and guidance.
2. In view thereof, all Schools Division Offices and Regional Office employees are hereby strongly advised to exercise prudence and caution and to refrain from entertaining, participating in, or engaging in any investment-related transactions or dealings with the said group.
3. All concerned are further enjoined to disseminate this information widely within their respective jurisdiction and/or offices to ensure that all teachers and personnel are properly informed and guided accordingly.
