



PHILSEA 101 Overview

International Law of the Sea (LOS) is a specialised area of international law which is at an intellectually distinct level only for those in the legal, scientific, and technical professions, creating educational gaps in elevating its international discipline and scientific character in Philippine universities, colleges, and secondary schools. To address the gaps, **PHILSEA 101** will be launching its **inaugural session** to simplify LOS at an introductory level for **Filipino undergraduate students and secondary school teachers**. This would allow them to gain the fundamental legal aptitude needed in holistically understanding LOS and improving LOS education in their respective academic institutions.

Eligibility

1. All applicants must have a **good command of English**.
2. All applicants must have a **strong internet connection**.
3. For an undergraduate student, the applicant must be a **bona fide student** of a higher education institution recognised in the Philippines.
4. For a secondary school teacher, the applicant must be a **Licensed Professional Teacher (LPT)** currently teaching in a recognised junior or senior high school in the Philippines.

Desirable Applicants

Desirable applicants must have **at least an introductory knowledge** on maritime security, maritime safety, marine biology, marine transportation and engineering, ocean governance, ocean and marine sciences, environmental sciences, hydrography, geography, geodetic and geomatics engineering, international relations, international security, **or any other related disciplines**.






Application Requirements

1. A coloured scanned copy of **Valid PRC ID (for Licensed Professional Teachers)** or a coloured scanned copy of **Valid School ID (for undergraduate students)**
 - Must be submitted in PDF format
2. A high-resolution digital copy of recent **photograph in business attire** (any size)
 - Must be submitted in PNG, JPG, or JPEG format
3. A clean, readable, and updated **Curriculum Vitae** (1-2 pages only)
 - No photograph
 - Personal information shall only indicate full name, citizenship, residential town and country, and LinkedIn Profile URL Link (if available)
 - Indicate educational background, honours/awards, relevant training, work/leadership experiences (if any) with description of duties, and other relevant details
 - Must be submitted in PDF format
4. An academic or professional **reference letter** (1 page only)
 - Typewritten in an official letterhead document of the institution of the referee
 - Contents shall specifically be for the purpose of attending PHILSEA 101 and shall elaborate the English language proficiency of the applicant
 - Dated within the application period
 - Signed by the referee
 - Preferably an academic lecturer, professor, or dean for undergraduate students
 - Preferably a head teacher, a department head, or a school principal for secondary school teachers
 - Must be submitted in PDF format
5. **Statement of purpose** (150 words maximum)
 - The applicant shall clearly explain their suitability for training, their motivation for attending PHILSEA 101, and relevant personal and/or professional goals
 - Typewritten directly on the application form



PHILSEA, established on **19 June 2023**, held its inaugural institutional training in collaboration with the Ateneo Society of International Law (ASIL) last **1-16 July 2023**. It had **12 lectures** yet conferred certificates to **44 completers**.
