In accordance with the multi-year theme **“WE for Gender Equality and an Inclusive Society (2023-2028),”** this office, through the Curriculum Implementation Division (CID), announces the observance of the 2026 National Women's Month Celebration (NWMC) this March. This year's sub-theme **“Lead Like the Babaylans, Filipinas!”** emphasizes leadership grounded on wisdom, empathy, and moral guidance.

2. The celebration aligns with the goals of the **4th ASEAN Women Leaders Summit** focusing on women's leadership in advancing people empowerment, regional security, and economic prosperity. By drawing inspiration from the Babaylan model, the 2026 NWMC highlights the role of Filipino women in driving inclusive governance and collaborative progress.

3. All schools must ensure meaningful observance of NWMC by undertaking the following:

- Conduct announcements, messages, and related activities during Flag Raising Ceremonies in the last week of February and the first week of March.
- Use the All-Women Cast “Lupang Hinirang” music video, available via the Philippine Commission on Women (PCW) online library, during official programs.
- For School Gender and Development Focal Point System (GFPS) to oversee the implementation of activities in coordination with the school management.
- Advocate wearing apparels with the shade of purple every Friday for the month of March to celebrate the NWMC.
